**BETT FEST COMPETITION TERMS AND CONDITIONS**

**1. The Competition Organiser**

1.1 The competition organiser is: Hyve UK Events Limited.

**2. The competition**

2.1 The title of the competition is BettFest Sweepstakes.

**2.2 COMPETITION MECHANICS**

- Answer the Poll shown during the session
- Your details will automatically go in the draw to win

**3. How to enter**

3.1 The competition will run from 14:00 on 20/01/2021 (the "**Opening Date**") to 17:05 on 21/01/2021 (the "**Closing Date**") inclusive.

3.2 All competition entries must be received by the Competition Organiser online by no later than 17:05 on the Closing Date. All competition entries received after the Closing Date are automatically disqualified.

3.3 To enter the competition:

- (a) Enter the competition online by registering to attend BettFest, attend one of the Microsoft content sessions and answer an online poll conducted during the eligible sessions.

3.4 No purchase necessary and there is no charge to register for use of the website

- 3.5 The Competition Organiser will **not** accept:
- (a) responsibility for competition entries that are lost, mislaid, damaged or delayed in transit, regardless of cause, including, for example, as a result of any postal failure, equipment failure, technical malfunction, systems, satellite, network, server, computer hardware or software failure of any kind; or

- 3.9 Registrants that take part in the BettFest Sweepstakes poll will automatically be entered into a draw, winners will be drawn at random and announced during BettFest on 22/01/2021.
- 3.10 Eligibility
- 3.11 The competition is only open to all residents in the UK aged 18 years or over, **except**:
- (a) employees of the Competition Organiser or its holding or subsidiary companies;
  - (b) employees of agents or suppliers of the Competition Organiser or its holding or subsidiary companies, who are professionally connected with the competition or its administration; or
  - (c) members of the immediate families or households of (a) and (b) above.
- 3.12 In entering the competition, you confirm that you are eligible to do so and eligible to claim any prize you may win. The Competition Organiser may require you to provide proof that you are eligible to enter the competition.
- 3.13 The Competition Organiser will not accept competition entries that are:
- (a) automatically generated by computer;
  - (b) completed by third parties or in bulk;
  - (c) illegible, have been altered, reconstructed, forged or tampered with;
  - (d) photocopies and not originals; or

(e) incomplete.

- 3.14 There is a limit of one entry per person, per session. Entries on behalf of another person will not be accepted and joint submissions are not allowed.
- 3.15 The Competition Organiser reserves all rights to disqualify you if your conduct is contrary to the spirit or intention of the prize competition.
- 3.16 Competition entries cannot be returned.

#### **4. The prize**

- 4.1 The prizes are 1x Surface Book 3, 2x Surface Laptop Go
- 4.2 Prizes are subject to availability. There is no cash alternative for the prize. The Competition Organiser reserves the right to substitute the prize with a prize of equal or greater value.
- 4.3 The prize is supplied by Hyve Group Plc (the "Supplier"). The Competition Organiser reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond the Competition Organiser's control makes it necessary to do so.
- 4.4 The prize is not negotiable or transferable.
- 4.5 In order to claim the prize you must respond to the email sent from a Bett representative confirming you are the winner, with confirmation of your postal address, age and identity.

#### **5. Winners**

- 5.1 The decision of the Competition Organiser is final and no correspondence or discussion will be entered into.
- 5.2 The Competition Organiser will contact the winner personally as soon as practicable after the Announcement Date, using the telephone number or email address provided with the competition entry. The Competition Organiser will not amend any contact information once the competition entry form has been submitted.
- 5.3 The Competition Organiser must either publish or make available information that indicates that a valid award took place. To comply with this obligation the Competition Organiser will send the surname and county of major prize winners and, if applicable copies of their winning entries, to anyone who emails [uk@bettshow.com](mailto:uk@bettshow.com) within one month after the Closing Date of the competition.

In such circumstances, the Competition Organiser must still provide the information and winning entry to the Advertising Standards Authority on request.
