### Tufting

Aspinwall's state-of-the-art tufting facility in Pollachi, Tamil Nadu, has a monthly capacity of 100,000 pieces and can be doubled with an additional shift.

### Printing

The factory's 20 printing stations can produce up to 35,000 pieces per month. Can produce 70000 pcs/ month with 2 shifts. Factory also has a capacity to add 20 more printing stations.

### Inspection and Packing

Aspinwall's experienced quality control team meticulously inspects each product before carefully packing them for safe transportation.

- ❖ One tufting line and adding another line capable of producing PVC backed as well as latex backed coir mat / Rolls by December 2024.
- ❖ 20 inhouse printing station and expanding to 40 stations by December 2024.
- ❖ Drying chamber for drying the mats after printing in the rainy season.
