Provides both new and experienced technicians with the technical and practical knowledge required to ensure competence and safe recovery & filling of refrigerant and servicing / diagnostics of Mobile Air Conditioning systems (MAC). Covering requirements of EC Regulation 307/2008, EC Regulation 842/2006 on certain fluorinated greenhouse gases (the F gas Regulation).

- Minimum of 4 and maximum of 6 people.
- **After training**, all successful candidates will be issued with a digital BAGMA certificate, City & Guilds certificates, ID skills card, Air Conditioning Performance Test pad.

All BAGMA accredited candidates are required to attend a revalidation training after five years with the exception of air conditioning which is a lifetime qualification unless legislation changes.
