

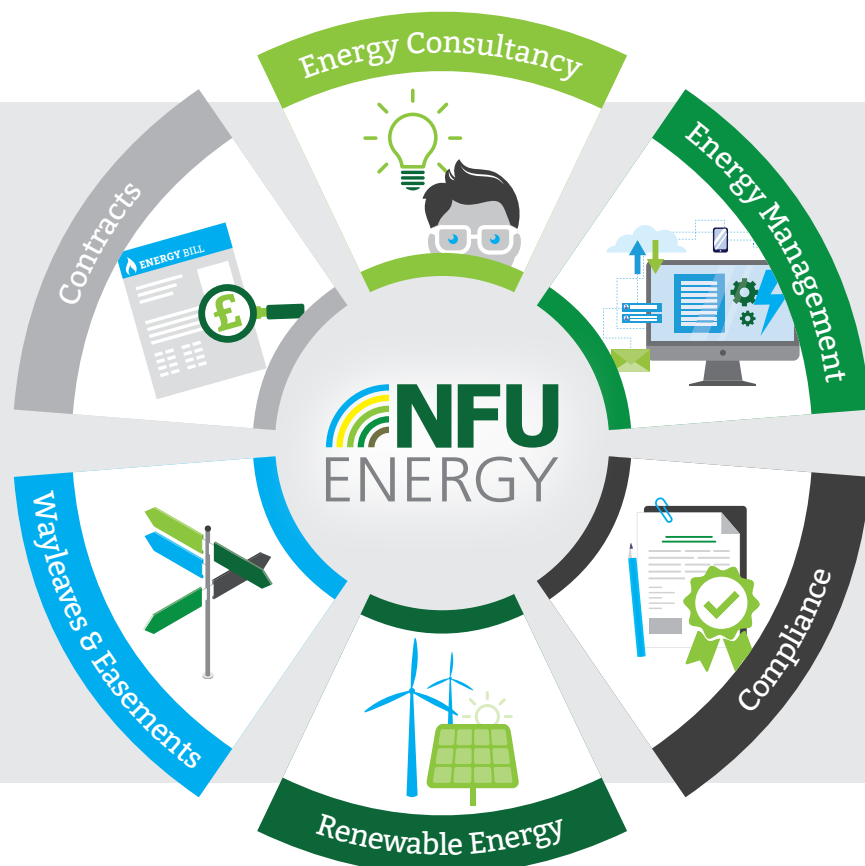

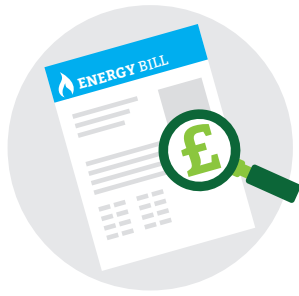

This service is right for you if:

- You spend more than £200,000 a year on gas.
- Have a Half-Hourly metered electricity supply and spend more than £80,000 a year.

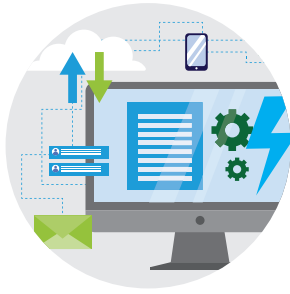

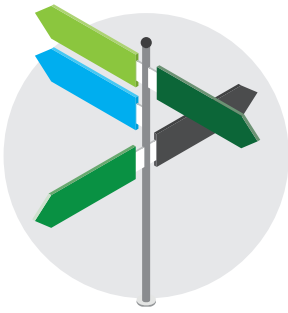

Wayleaves and Easements

In an ever-evolving energy landscape, obtaining the necessary permissions and agreements for the installation and maintenance of essential infrastructure is a critical process. Our tailored service not only streamlines this process but also empowers businesses, landowners, and energy developers to unlock the true potential of their projects without the hurdles of administrative challenges.

If you own electrical equipment, you may receive letters informing you about potential payments in exchange for granting a wayleave or easement. These agreements, made between landowners and Distribution Network Operators (DNOs), provide the necessary rights for maintaining and repairing existing electricity apparatus.

If powerlines are hindering the potential use of your property, such as for development, it may be possible to relocate or place them underground.



How it works

We offer a complementary eligibility check to help you determine the best course of action. We can then negotiate with your DNO on your behalf, ensuring that the work aligns with your legal rights. Even if your DNO has provided a quotation for the work – which can often be significant, sometimes amounting to tens of thousands of pounds – we may be able to substantially reduce the cost.

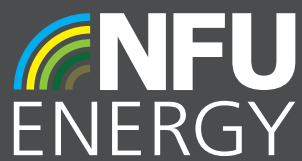
