On-Programme Training

The on-programme training is the learning phase for the apprentice to:

- develop the knowledge, skills and behaviours (KSBs) of the occupational standard.
- undertake training towards English and mathematics Level 2, if required
- compile a portfolio of evidence.

#### The Gateway

When the on-programme training is complete the apprentice will enter the Gateway and the employer will need to submit the following:

- Confirmation that the apprentice is working at or above the level of the occupational standard.
- Evidence to show that the apprentice has achieved a Level 2 qualification in English and maths.
- A portfolio of evidence to underpin the professional discussion only and is not directly assessed.

## End-Point Assessment methods

The Operational Firefighter EPA has 3 assessment methods which can be carried out in any order. completion of a multi-choice test, a practical assessment with questioning and a professional discussion. SFJ Awards will ensure the appropriate allocation of the independent assessor (IA) is made and our internal quality assurance team will assure consistent quality of assessment.

#### **Knowledge Test**

The 30 multiple knowledge test questions have four possible answers, only one of these will be correct. The test will last for 60 minutes and is available as an online test of paper based.

#### **Practical Assessment**

The practical observation element will be carried out over a total of six hours in cohorts of 1:4. The practical assessment will be pre-planned and staged in simulated tasks using Realistic Working Environments. The apprentice will be asked two questions following each task.

#### **Professional Discussion**

The Profession Discussion lasts for 60 minutes and is two-way conversation between the Apprentice and the Independent Assessor. It involves questions that focus on assessment of competence against the KSBs. Apprentices may refer to and illustrate their answers with evidence from their portfolio of evidence.
