



Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, October 13-16, 2025, naming Business Show Media Inc (11 Trevino Rd, Flanders, NJ, 07836) as the certificate holder. The following must be listed as additional insured: Business Show Media Inc and Las Vegas Convention and Visitors Authority.

Rainprotection Insurance Program
