

COLLABORATIVE AND INNOVATIVE ECOSYSTEM

Georgia is a true innovation hub with a high concentration of companies that invest heavily in R&D. The state's investment in its thinkers and doers has created an ecosystem of corporate innovation centers, research universities, incubators, and accelerators. Over the past five years, Atlanta has experienced a 15% growth in tech jobs. Additionally, the city ranks 4th for tech talent diversity, which has spurred Apple, Google, Microsoft, and Visa to open offices in the metro.

Tech Square is "one of the nation's leading destinations for corporate research centers," according to the Harvard Business Review. The eight-block area in Midtown Atlanta has the highest density of startups in the Southeast, providing proximity for interactions with other researchers, venture capitalists, and Georgia Tech students. Many international brands, including Anthem, Delta Air Lines, The Home Depot, and Panasonic Automotive, house their innovation labs in Tech Square's high-performance computing space.







WORKFORCE

Georgia is the 8th largest state in the U.S. with a total population of 10.6 million people, and is projected to grow by 25% from 2018 to 2038.

In addition to recent graduates from technical colleges and nationally ranked universities, Georgia's workforce benefits from a near-constant influx of skilled and experienced workers discharged from the military. There are more than 700,000 veterans living in the state; many companies, especially in cybersecurity, defense, and aerospace industries proudly claim veterans as a sizable portion of their workforce.



HOPE SCHOLARSHIP AND GRANT PROGRAM

Georgia's HOPE scholarship was the first merit-based state scholarship in the U.S. and continues to be one of the largest. The HOPE Grant provides tuition assistance to students pursuing a certificate or diploma. Since its launch in 1993, the HOPE program has provided more than \$12.6 billion to over 2 million top performing students pursuing education beyond high school.

The HOPE Career Grant is a state-funded grant that supplements the HOPE Grant and results in free tuition, as well as other fees, for Technical College System of Georgia students learning skills needed for high-demand careers. 
THE RESEARCH ADVANTAGE

Georgia's universities do much more than produce an educated workforce. The state's research universities – which generate more than \$2 billion a year in public and private R&D funding – work closely together through the Georgia Research Alliance (GRA), a national model for university research collaboration. GRA expands research capacity at universities, then seeds and shapes startup companies around inventions and discoveries. THE BUSINESS ADVANTAGE

Over the years, Georgia's business-friendly approach has earned the state a range of accolades. Area Development magazine, citing the state's "reasonable statutes, sound economic development policy, and strong business development support," has awarded Georgia 1st place for Cooperative State Government for eight consecutive years. A right-to-work state, with low unionization, a favorable regulatory environment, and the number one workforce training program in the nation make Georgia the ideal place for companies to relocate or expand.



CERTIFIED SITE PROGRAM

Since 2008, Georgia has provided a "shovel ready" program to help companies quickly identify optimal locations available for fast-track construction projects. There are 60 sites in the Georgia Ready for Accelerated Development (GRAD) program along with an extensive inventory of existing industrial and commercial properties. TAX ADVANTAGE

Georgia has consistently fostered business-friendly financial and regulatory policies creating an environment on which businesses can rely.

STEADY GOVERNMENTAL FOUNDATION

- Maintains a AAA rating from all three credit agencies for over 20 years.
- Georgia's main incentives for job creation have been in place for more than 25 years.
- Some tax credits can be applied to state payroll withholding liability.
- Favorable corporate income tax structure, ranked 6th in the U.S. by the Tax Foundation, in place for 50 years until is was lowered in 2019.
- Georgia's environmental permitting program is consolidated with the U.S. Environmental Protection Agency (EPA) to expedite the permit process.

TAX RATES

The corporate tax rate in Georgia of 5.75% is among the lowest in the nation. Additionally, Georgia uses a Single Factor Gross Receipts formula, which significantly reduces the effective rate of Georgia income taxation for companies with substantial sales to customers outside of the state. In addition, Georgia does not use the "Throw Back Rule" to tax income from sales to customers outside Georgia if it is not taxed by the customer's state.

TAX EXEMPTIONS

Sales & Use Tax Exemptions helps Georgia companies lower their cost of doing business by offering the ability to purchase various types of goods and services tax free. Industries eligible for exemptions include manufacturing, data centers, and distribution centers.

TAX CREDITS

Our portfolio of incentives begins with a tax credit to spur job creation, and includes an array of credits listed below. Georgia's statutory credits reduce corporate tax liability, and in some cases, reduce payroll withholding — essentially generating new cash flow for your company.





With more than 1 million foreign born residents, the state's international population has risen in the past few decades from 3% to 10%. The majority of immigrants are from Latin America and Asia. After English, Spanish and Korean are the most frequently spoken languages.

Cultural, language, and heritage institutions scattered across Georgia bring together diverse communities for festivals and regular events, like the Macon Cherry Blossom Festival, which highlights the longstanding ties between Georgia and Japan, or Savannah's St. Patrick's Day, the largest celebration of the holiday outside of Ireland.
