Deadline for Dispatch of Documents (Pre-Alerts)

To ensure no delays or undue inconvenience for customs clearance on arrival, it is imperative that copy of the vessel/flight details with master air waybill / ocean bill of lading detail be forwarded well in advance before the arrival of shipments according to the stipulated deadlines above.

DSV will not be responsible for any delays and any port/airport storage charges will be re-charged at cost. **For late submission of documents, a penalty fee will be charge at cost - as per receipt.**

IMPORTANT

Please send a pre-alert no later than 1 (one) day prior to arrival in accordance with the directives from the Indonesian Finance Ministry's No. 158/PMK.04/2017 and the Directorate of Custom and Excise's No. Per-38/BC/2017, which stated that EDI manifests be submitted to Indonesian Customs at the latest 24 hours before a flight's departure or arrival date.

Late and incorrect data manifest wil lead to progressive Custom Penalty ranging from IDR 10,000,000.00 - IDR 100,000,000.00/shipment.

In Addition, there will be a Custom Penalty for incorrect declaration of quantity and weight (Data VS Actual), penalty ranging from IDR 25,000,000.00 - IDR 100,000,000.00/shipment.

CUSTOMS DECLARATION

All items must be declared on the commercial invoice and packing list (CIPL) without exemption, a customs import permit will be given to each exhibitor for each document. Please ensure to indicate the real name of exhibitor in the CIPL.

Customs fees will be assessed if there is any discrepancy between the shipping document and the actual cargo. The penalty ranging from USD2,500 - USD25,000.

All temporary imports must be shipped back to their point of origin or any other country as soon as possible after the show end to avoid any customs penalty.

Permanent import permit only applicable for Promotion Material i.e brochure, flyer, or any printed material and souvenir as long as no special permit required. Please be note that permanent import for such items are subject to duty & taxes. We suggest to contact our team to check the import permit prior departure, please do not send cargo prior receiving DSV's approval.

IMPORTANT NOTE:

The HS Code listed on the commercial invoice and packing list will be used as the basis for all duty and tax computations. Customs authorities have the authority to change the HS Code if its not match with the actual cargo and increase the declared CIF value if its declared under than actual market value.

The Indonesian Customs Amendment Rights is valid for ten (10) years from date of import and exhibitors or buyers are still liable for any missed declarations. In such circumstances, a severe penalty and the remaining duty/taxes are due.

Insurance
