Your traffic booking process

Your traffic booking process – a step by step guide

STEP 1:

Access the transport management system.

STEP 2:

Book your designated arrival slot and time.

STEP 3:

Receive automatic confirmation, including slot reference number and QR code. Please ensure this is given to your driver.

STEP 4:

Driver arrives at marshalling yard for ICE & iGBA 2025 with QR code or reference, prior to booking slot.

STEP5:

Vehicle is matched with booking slot and provided with access accreditation

STEP6:

Vehicle is processed and departs Fira Barcelona (when space is available)









A guide to access fees for ICE & IGB 2025

In order to secure a booking slot, all fees need to be paid, either in advance, or upon the driver's arrival in the marshalling yard.

To note, access fees are per vehicle, not per booking.




How to find the Vehicle Marshalling Yard

LOGISTIC AREA SOT DEL MIGDIA

All vehicles prior to entry into ICE & IGB 2025 will be required to attend the vehicle marshalling yard, also known as "SOT". Vehicles will be processed and receive the necessary accreditation to access the venue so please ensure timely arrival prior to your designated access slot to ensure adequate time for processing. Vehicles arriving directly to the venue without the necessary accreditation will be turned away and sent to the vehicle marshalling yard.

Please arrive to SOT 1 hr prior to your confirmed STM booking slot for processing

FAQs		
Q1: Can I skip the SOT and go straight to the fairground?	A1: All vehicles must attend the vehicle marshalling yard, commonly known as SOT for processing and to receive accreditation for venue access. Direct access to the venue is not permitted.	
Q2: Can I unload my goods directly from my car at the venue?	A2: Cars are permitted at the designated parking areas for the venue where goods can be transferred from car into the venue.	
Q3: Do I have to pay the access fees in advance?	A3: No, you can either pay in advance or you can pay access fees once your driver arrives at the marshalling yard.	
Q4: Can I pay the access fees onsite?	A4: Yes, you can pay access fees once your driver arrives at the marshalling yard.	
Q5: Do I need a vehicle booking slot?	A5: Yes, all vehicles will need a pre booked slot before arriving at the vehicle marshalling yard.	
Q6: What if I need to amend my booking?	A6: Our system can be amended and remains flexible after a booking is made, any issues we suggest to contact our event team for further support.	
Q7: When do I need to arrive at SOT?	A7: We recommend you arrive 1hr prior to your required time slot confirmed by the KN STM.
