## The Art Printorium Ltd

### Wholesale Terms

#### 1. Sale of Goods and Terms

1.1 The Art Printorium Ltd trading as House of MinaLima, company no. 07977737 registered office address 17 Station Road, Sunbury-On-Thames TW16 6SB, UK ("Seller") sells the goods set out on the order or the schedule to these terms ("Order") ("Goods") to the customer set out on the Order ("Buyer") on these Terms of this Agreement. The Buyer may resell the Goods in its stores, through third parties or online at its sole discretion but shall ensure at all times it maintains the premium brand image of the Goods.

1.2 No contract terms of the Buyer shall apply between the parties relating to the sale of Goods between them including without limitation on any Buyer purchase order. This Agreement is the entire agreement between the parties as to its subject matter. Where the Order conflicts with the terms of the Agreement the Order prevails.

1.3 The Seller's employees or agents are not authorised to make any representations concerning the Goods unless confirmed by the Seller in writing. In entering into the Agreement the Buyer acknowledges that it does not rely on, and waives any claim for breach of, any such representations which are not so confirmed.

1.4 No variation to these Terms shall be binding unless agreed in writing between the authorised representatives of the Buyer and the Seller.

1.5 Sales literature, price lists and other documents issued by the Seller in relation to the Goods are subject to alteration without notice and do not constitute offers to sell the Goods which are capable of acceptance.

1.6 Any typographical, clerical or other accidental errors or omissions in any sales literature, quotation, price list, acceptance of offer, invoice or other document or information issued by the Seller shall be subject to correction without any liability on the part of the Seller.

1.7 Where the Buyer has undertaken to buy annual minimum quantities of the Goods as set out in special conditions on the Order ("Special Conditions") the Buyer agrees it shall purchase that quantity within the period set out in the Special Conditions.

#### 2. Orders

2.1 No purchase order submitted by the Buyer shall be deemed to be accepted by the Seller unless and until confirmed in writing by the Seller's authorised representative. The Seller reserves the right to reject any order at its discretion and also to cancel an accepted order within 7 days of placing of the order without liability on the part of the Seller. In such cases the Buyer would be given a refund by the Seller where the payment of the Goods had already been made. Where an order is received the Seller shall notify the Buyer if any item is out of stock and shall give the Buyer the option of changing its order.

2.2 The description of the Goods is as set out in the Agreement above unless varied expressly in the Buyer's order (if such variation(s) is/are accepted by the Seller). The Goods will only be supplied in the minimum units thereof stated in the Seller's price list or in multiples of those units or as set out in the

Agreement above. Orders received for quantities other than these will be adjusted accordingly.

2.3 Illustrations, photographs or descriptions whether in catalogues, brochures, price lists or other documents issued by the Seller are intended as a guide only and shall not be binding on the Seller.

2.4 No order which has been accepted by the Seller may be cancelled by the Buyer except with the agreement in writing of the Seller on the terms that the Buyer shall indemnify the Seller in full against all loss (including loss of profit), costs (including the cost of all labour and materials used), damages, charges and expenses incurred by the Seller as a result of such cancellation.

2.5 The Buyer where subsequent orders are envisaged should aim to indicate to the Seller approximate future volumes required by month so that demand can be met.

#### 3. Price

3.1 The price of the Goods is set out on the Agreement above and/or in subsequent purchase orders once agreed by the Seller. All payments must be made in pounds sterling (GBP) in cleared funds to the bank account of the Seller nominated to the Buyer. Usually unless otherwise agreed the first three orders will require payment in advance before the Buyer can apply for 30 day credit terms. After three successful orders, the Buyer may apply for 30 days credit terms and must provide three years of accounts and three trade references for consideration. The request for credit terms must be made via email to [finance@minalima.com](mailto:finance@minalima.com).

3.2 Prices quoted remain open for acceptance by the Buyer for 30 days (except where a fixed price is agreed between the parties for a set period). Unless otherwise agreed wholesale prices are subject to change on one month's notice to the Buyer.

3.3 The Seller reserves the right, by giving written notice to the Buyer at any time before delivery, to increase the price of the Goods to reflect any increase in the cost to the Seller which is due to any factor beyond the control of the Seller (including, without limitation, any foreign exchange fluctuation, currency regulation, alteration of duties, significant increase in the costs of labour, materials or other costs of manufacture), any change in delivery dates, quantities or specifications for the Goods which are requested by the Buyer, or any delay caused by any instructions of the Buyer or failure of the Buyer to give the Seller adequate information or instructions.

3.4 Unless otherwise stated on the Agreement all prices are ex works with the Buyer responsible for collection of the Goods from the Seller's nominated warehouse, with all transport charges and customs duties paid by the Buyer. The Seller shall ensure the Goods are packed at its own expense ready for such collection.

3.5 The price is exclusive of any applicable value added tax, excise, sales taxes or levies of a similar nature which are imposed or charged by any competent fiscal authority in respect of the Goods, which the Buyer shall be additionally liable to pay to the Seller. In particular UK Buyers need to add VAT at then prevailing rates (currently 20%) to the prices quoted.

3.5 The Buyer shall have no right to set off any sums owed to the Seller in relation to any other sum owed between the parties or for any other reason.

#### 4. Payment

4.1 Subject to any Special Terms agreed in writing between the Buyer and the Seller and attached to this Agreement ("Special Terms"), the Seller shall invoice the Buyer for the price of the Goods at or any time after dispatch of the Goods, unless the Goods are to be collected by the Buyer or the Buyer wrongfully fails to take delivery of the Goods, in which event the Seller shall be entitled to invoice the Buyer for the price at any time after the Seller has notified the Buyer that the Goods are ready for collection or (as the case may be) the Seller has tendered delivery of the Goods.

4.2 Where the Buyer is not required to pay in advance for the Goods, the Buyer shall pay the price of the Goods within 30 days of invoice or otherwise in accordance with such credit terms as may have been agreed in writing between the Buyer and the Seller. Payment shall be made by the due date notwithstanding that delivery may not have taken place and/or that the property of the Goods has not passed to the Buyer. The time for the payment of the price shall be of the essence of this Agreement. Receipts for payment will be issued only upon request.

4.3 All payments shall be made to the Seller as indicated on the form of acceptance or invoice issued by the Seller.

4.4 The Seller is not obliged to accept orders from any customer or buyer who has not supplied the Seller with references satisfactory to the Seller. If at any time the Seller is not satisfied as to the creditworthiness of the Buyer it may give notice in writing to the Buyer that no further credit will be allowed to the Buyer in which event no further Goods will be delivered to the Buyer other than against cash payment and notwithstanding any other provision of this Agreement, all amounts owing by the Buyer to the Seller shall be immediately payable in cash.

4.5 Any recommended price supplied with the Products (RRP) is provided as a guide only.

4.6 The Goods may not be resold on third party websites or marketplaces including without limitation Amazon or eBay. The Buyer agrees to ensure the Goods are not resold in that manner and to include a similar clause in its contracts with its customers of the Goods. The Seller also reserves the right to work with authorised distributors who may be the only parties allowed to resell the Goods in a particular region. As the Goods are protected by intellectual property rights export of them to certain countries may not be permitted without the rights owner's permission. If in doubt, the Buyer should ask the Seller before purchase of the Goods. This preserves the premium image of the brand MinaLima.

#### 5. Supply of Goods and Collection

5.1 The Buyer shall collect the Goods from the Seller (i.e. supply is on an ex works basis) unless otherwise agreed or set out in the Special Terms. The collection/dispatch address is as agreed in the Order.

5.2 Where the Seller agrees to deliver the Goods to the Buyer shipping costs shall be paid by the Buyer and quotes for the shipping options will be supplied to the Buyer before shipment and shipping will be invoiced as a separate item on each order.

5.3 The delivery date is approximate only (i.e. time for making the Goods available for collection shall not be of the essence). The Seller may have the Goods available for collection in advance of the delivery date upon giving reasonable notice to the Buyer. The Buyer shall ensure it collects the Goods by or on

the date agreed between the parties and time shall be of the essence for such collection.

5.4 Where the Goods are to be provided in instalments, each delivery shall constitute a separate Agreement and failure by the Seller to deliver any one or more of the instalments in accordance with these terms or any claim by the Buyer in respect of any one or more instalments shall not entitle the Buyer to treat the Agreement as a whole as repudiated.

5.5 If the Buyer fails to collect the Goods or any part of them on the delivery date and/or fails to provide any instructions, documents, licences, consents or authorisations required to enable the Goods to be delivered on that date, the Seller shall be entitled upon giving written notice to the Buyer to store or arrange for the storage of the Goods and then risk in the Goods shall pass to the Buyer, delivery shall be deemed to have taken place and the Buyer shall pay to the Seller all costs and expenses including storage and insurance charges arising from such failure.

5.6 The Buyer is under a duty whenever possible to inspect the Goods on delivery. All issues with the Goods must be notified to the Seller within 5 working days of delivery of the Goods from the Seller by email to [wholesale@minalima.com](mailto:wholesale@minalima.com) or such other address as is notified to the Buyer by the Supplier for this purpose from time to time.

5.7 The Seller shall be under no liability for any damage or shortages that would be apparent on reasonable careful inspection if not notified to Seller within 5 working days setting out the alleged damage or shortage. Photographic evidence should be supplied of any damage to cartons or products.

5.8 In such cases the Seller shall be under no liability in respect of an alleged defect or shortage unless an opportunity to inspect the Goods is supplied to the Seller before any use is made of them and before any resale by the Buyer.

5.9 Subject to the above, the Seller shall make good any shortage in the Goods and where appropriate replace any Goods which do not comply with the requirements of this Agreement as soon as it is reasonable to do so, but otherwise shall be under no liability whatsoever arising from such shortage or damage.

#### 6. Warranties, Risk and Title and Quality of Marketing

6.1 The Seller warrants that the Goods are of satisfactory quality and fit for their purpose and shall comply with the description given to the Buyer. The Seller aims to ensure all Goods comply with their description and colours are accurate and the like. The Seller does not guarantee all images/prints and others of the Goods will be identical as printing processes and inks vary. The

Seller accepts no liability to the Buyer for any such slight variations. Any sizes of Goods given are approximate only.

6.2 Risk of damage to or loss of the Goods and title to the Goods shall pass to the Buyer on collection of the Goods from the Seller (or where Seller arranges despatch when handed over the delivery company engaged for this purpose).

6.3 The Buyer shall insure the Goods from the time it collects them from the Seller. Where the Seller arranges delivery the Goods are at the risk of the Buyer from the point of collection.

6.4 The Buyer shall ensure all marketing of the Goods is undertaken in a competent and accurate manner and display stands are kept in good order at all times in the store where the Goods are displayed. Where the Seller provides racking and other display and marketing material for Goods displays these remain the property of the Seller and must be returned to the Seller when this Agreement terminates or otherwise on reasonable demand. The Seller shall have the right on reasonable notice to inspect store displays of Goods at any time to ensure Goods are being given appropriate prominence in the store and



## 7. Non-Conformance of Goods with the Agreement

7.1 If on delivery any of the Goods that have been supplied are in breach of the obligations under this Agreement in any material respect and either the Buyer lawfully refuses to collect the Goods, the Seller shall, at its option:

(a) replace the Goods within 30 days of receiving the Buyer's notice; or

(b) refund to the Buyer the price for those Goods (or parts thereof, as appropriate);

and the Seller shall have no further liability to the Buyer in respect thereof.

No Goods should be returned without obtaining the Seller's prior approval in advance and only where full details are given of the address and other delivery instructions.

7.2 No Goods may be returned to the Seller without the prior agreement in writing of the Seller. Subject to this any Goods returned which the Seller is satisfied were supplied in breach of this Agreement where the failure could not be seen on inspecting the Goods shall either be replaced free of charge or, at the Seller's sole discretion the Seller shall refund or credit the Buyer the price of such Goods and the Seller shall have no further liability to the Buyer arising from such failure.

7.3 The Seller shall be under no liability in respect of any defect arising from fair wear and tear, or any wilful damage, negligence, subject to normal terms, failure to follow the Seller's instructions (whether given orally or in writing), misuse or alteration of the Goods without the Seller's prior approval, or any other act or omission on the part of the Buyer, its employees or agents or any third party.

7.4 Subject as expressly provided in these terms and save that the Seller warrants that it owns the Goods, all warranties, terms or other terms implied by statute or common law are excluded to the fullest extent permitted by law.

7.5 Except in respect of death or personal injury caused by the Seller's negligence, or as expressly provided in these terms, the Seller shall not be liable to the Buyer by reason of any representation, or any implied warranty, condition or other term, or any duty at common law or under statute, or under the express terms of the Agreement.

7.6 The Buyer shall be responsible for ensuring that, except to the extent that instructions as to the use or sale of the Goods are contained in the packaging or labelling of the Goods, any use or sale of the Goods by the Buyer is in compliance with all applicable statutory requirements and that handling and sale of the Goods by the Buyer is carried out in accordance with directions given by the Seller or any competent governmental or regulatory authority and the Buyer will indemnify the Seller against any liability loss or damage which the Seller might suffer as a result of the Buyer's failure to comply with this condition.

## 8. Buyer's Default

8.1 If the Buyer fails to make any payment on the due date then, without prejudice to any other right or remedy available to the Seller, the Seller shall be entitled to:

(c) charge the Buyer interest at the UK statutory rate of 5% above Bank of England base rate from time to time in addition to UK statutory collection charges.

8.2 Sub clause 8.3 below applies if:

(a) the Buyer fails to perform or observe any of its obligations hereunder or is otherwise in breach of the Agreement;

(b) the Buyer becomes subject to an administration order enters into a voluntary arrangement under Parts I or VIII of the Insolvency Act 1986 or the Insolvent Partnerships Order 1994 or (being an individual or firm) becomes bankrupt or (being a company) goes into liquidation; an encumbrancer takes possession, or a receiver is appointed, of any of the property or assets of the Buyer; the Buyer ceases, or threatens to cease, to carry on business; or the Seller reasonably apprehends that any of the events mentioned above is about to occur in relation to the Buyer and notifies the Buyer accordingly; or in all cases a similar event occurs in relation to the Buyer in the jurisdiction to which the Buyer is subject.

8.3 If the sub-clause above applies then, without prejudice to any other right or remedy available to the Seller, the Seller shall be entitled to terminate this Agreement or suspend any further deliveries of Goods under the Agreement without any liability to the Buyer, and if the Goods have been delivered but payment has not been paid for them then the price shall become immediately due and payable notwithstanding any previous agreement or arrangement to the contrary.

8.4 The Buyer shall fully indemnify and hold the Seller harmless against all loss and liability including third party claims against the Seller arising from breach by the Buyer of any provision of this Agreement.

## 9. Limitation of Liability

9.1 Nothing in these terms excludes or limits the liability of the Seller:

(a) for death or personal injury caused by the Seller's negligence;

(b) for fraud or fraudulent misrepresentation.

9.2 Subject as provided above:

(a) the Seller's total liability in Agreement, tort (including negligence or breach of statutory duty), misrepresentation, restitution or otherwise, arising in connection with the performance or contemplated performance of the Agreement shall be limited to the purchase price paid for Goods by the Buyer to the Seller in the 12 months prior to any claim.; and

(b) the Seller shall not be liable to the Buyer for any pure economic loss, loss of profit, loss of business, depletion of goodwill or otherwise, in each case whether direct, indirect or consequential, or any claims for consequential compensation whatsoever (howsoever caused) which arise out of or in connection with the Agreement.

## 10. Confidentiality and Intellectual Property

10.1 The parties shall keep strictly confidential all information about the other party, its products, suppliers, designers, profits, the terms of this Agreement and all other information of a financial and product nature (other than information in the public domain or required to be disclosed by law) ("Confidential

Information") and shall only use Confidential Information of the other party for the purposes of this Agreement.

10.2 The Goods contain valuable intellectual property of the Seller or its licensors and the Buyer undertakes not to use or copy any such intellectual property including in marketing of the Goods. All marketing should be pre-approved by the Seller. The Buyer acknowledges it understands that the Seller works under strict conditions relating to use of intellectual property imposed by its book publishers and in relation to Wizarding World material licensed by Warner Brothers and/or Pottermore. Where Goods are customised for the Seller the Buyer shall retain all intellectual property rights in such customisation work.

10.3 The Buyer will not use, authorise or permit any other person to use any name, trademark including "MinaLima" which is a registered trade mark, house mark, emblem or symbol which the Seller is licensed to use or which is owned by the Seller upon any premises, note paper, visiting cards, advertisement or other printed matter or in any other manner whatsoever unless such use shall have been previously authorised in writing by the Seller and (where appropriate) its licensors.

10.4 The Buyer shall not register any intellectual property rights or limited company names or domain names which are or are similar to those of the Seller or its licensors.

10.5 The Buyer may not adapt, modify or incorporate the Goods into any other products whether online or offline. The Buyer may not commercialise or otherwise publish any image of them without prior consent from the Seller. Any photographs or displays of the Goods must bear a copyright notice © *MinaLima Ltd and its Licensors 2023. All Rights Reserved.*

10.6 The provisions of this Clause 10 shall survive the termination of the Agreement.

## 11. General

All notices under this Agreement shall be in writing and be deemed duly given if signed by, or on behalf of, a duly authorised officer of the party giving the notice to the parties' addresses on the order. Neither party shall be liable for any

failure or delay in performing their obligations where such failure or delay results from any cause that is beyond the reasonable control of that party. Such causes include, but are not limited to: power failure, internet service provider failure, industrial action, civil unrest, fire, flood, storms, earthquakes, acts of terrorism, acts of war, governmental action or any other event that is beyond the control of the party in question. The parties agree that no failure by either party to enforce the performance of any provision in this Agreement shall constitute a waiver of the right to subsequently enforce that provision or any other provision. Such failure shall not be deemed to be a waiver of any preceding or subsequent breach and shall not constitute a continuing waiver. The parties agree that, in the event that one or more of the provisions of this Agreement are found to be unlawful, invalid or otherwise unenforceable, those provisions shall be deemed severed. The remainder shall be valid and enforceable. The Seller may assign the Agreement or any part of it to any person, firm or company without the prior written consent of the Buyer. The Buyer shall not be entitled to assign the Agreement or any part of it without the prior written consent of the Seller. A person who is not a party to the Agreement shall have no rights under the Agreement pursuant to the Agreements (Rights of Third Parties) Act 1999. The Buyer undertakes not to pass personal data to the Seller unless it has a lawful basis to do so under applicable local data protection legislation (and in the UK under UK GDPR and the Data Protection Act 2018 as amended). Where the Seller places the Buyer's details on its customer database all subsequent marketing emails are sent with a method to opt-out from such future marketing. The Buyer agrees to act in an ethical manner at all times in relation to this Agreement and not to take or make any bribe, secret commission or enter into any anti-competitive practice or abusive conduct whether in breach of applicable competition law or otherwise, nor to engage in its supply chain in any slavery or other breaches of the law. The Buyer shall also comply with any reasonable corporate governance policies of the Seller and/or Warner Bros to which the Seller is subject where applicable to this Agreement. This Agreement shall be governed by, and construed in accordance with, the laws of England and Wales. The parties agree to submit to the non-exclusive jurisdiction of the courts of England and Wales in connection with any dispute under this Agreement.
