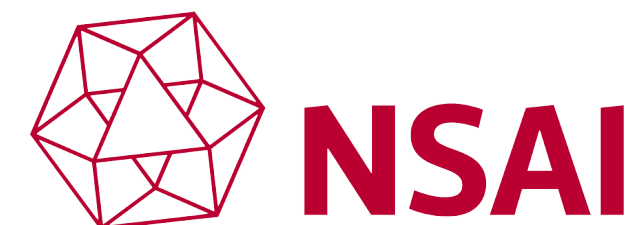

# TECHNICAL SERVICE



## CONFORMITY OF PRODUCTION

ATS Group, through its dedicated COP & surveillance team, conducts audits aimed at the initial and periodic evaluation of the production process and the approved product.

## ACCREDITED LABORATORY

ATS Group, for the execution of tests subject to inspection activities, relies on laboratories accredited according to the ISO/IEC 17025:2017 standard. In cases where they are not accredited, it is still able to conduct an audit to recognize the laboratory as suitable for performing the tests.

## TYPE APPROVALS

ATS Group carries out testing and inspection activities through its extensive network of inspectors and affiliated laboratories, aimed at obtaining the Type Approval certificate according to ECE and EU Regulations.

## VEHICLES AND SYSTEMS CATEGORIES FOR TYPE APPROVAL

- CATEGORY M, N, O: passenger cars, vans, buses, trucks, and trailers.
- CATEGORY L: motorcycles, scooters, mopeds, tricycles, and quadricycles.
- CATEGORY T, C, R, S: tractors, harvesters, agricultural trailers, and towed machinery.
- NON-ROAD MOBILE MACHINERY (NRMM): engines for construction machinery, generators, industrial and naval sector.
- INDIVIDUAL APPROVALS: prototypes, one-off Vehicles, and specially imported models not covered by Type Approval.
- INDEPENDENT COMPONENTS, SYSTEMS, AND TECHNICAL UNITS: lighting systems, ADAS systems, seatbelts, tyres and electronic control units (ECUs)





## ELECTRIC VEHICLES TYPE APPROVAL

ATS Group offers comprehensive services for the Type Approval of electric Vehicles, acting as a strategic partner for manufacturers who wish to introduce their products to the European and international markets.

The Whole Vehicle Type Approval (WVTA) is a fundamental step to ensure that electric Vehicles meet all safety and environmental requirements. The regulatory basis for WVTA in the EU is Regulation (EU) 2018/858, which establishes the administrative framework and procedures for the approval and market surveillance of motor Vehicles, including electric Vehicles, and their components.





## TYPE APPROVAL OF THE MAIN UNECE REGULATIONS

### ELECTROMAGNETIC COMPATIBILITY

It ensures that Vehicles and their electronic sub-assemblies (ESAs) do not cause excessive electromagnetic interference (EMI) that could disrupt other electronic devices.

### LIGHTING SYSTEMS

From Full LED headlights to Matrix and Laser systems, new technologies provide greater safety, efficiency, and comfort. Our accredited laboratories are capable of performing tests with the highest level of reliability.

### TYRES

Tyres are tested in proving grounds on mixed surfaces and under various climatic conditions, ensuring performance, safety, and reliability essential for every Vehicle on the road.





## TYPE APPROVAL OF THE MAIN UNECE REGULATIONS

### ACTIVE SAFETY (ADAS)

ADAS systems are tested in proving grounds, simulating real scenarios and variable weather conditions to ensure active safety, driver assistance, and reliable performance in every potential danger situation.

### PASSIVE SAFETY

Passive safety includes laboratory testing systems such as airbags, seatbelts, and impact-absorbing structures, designed to reduce the consequences of an accident and effectively protect drivers and passengers.

### NOISE POLLUTION

Reducing noise pollution in Vehicles enhances comfort, safety, and quality of life. Specific tests measure sound emissions, helping develop quieter, more environmentally friendly cars.

### VISIBILITY

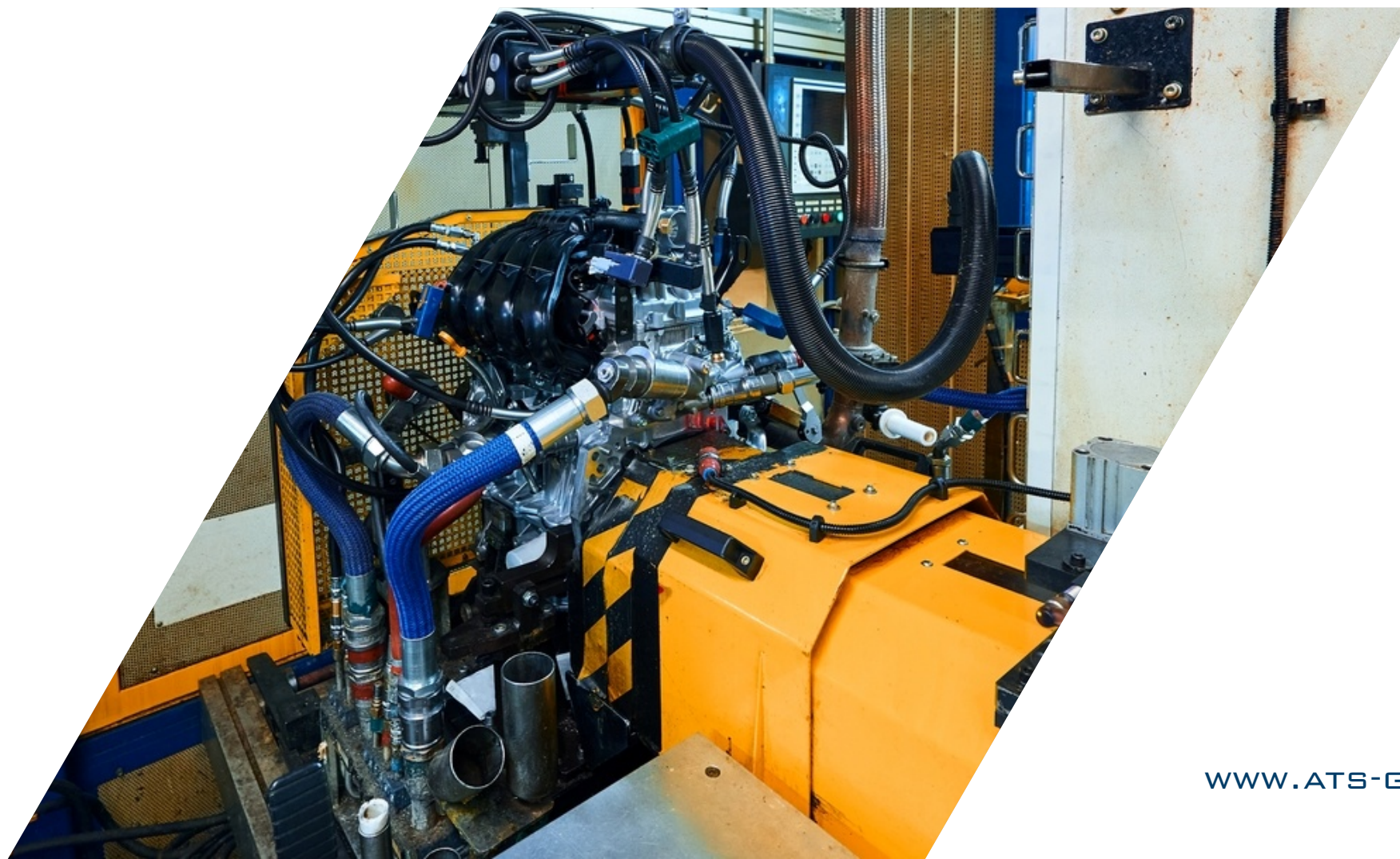

### EMISSIONS

Controlling emissions is essential to reduce the environmental impact of Vehicles. Accurate testing measures gases and particulates, ensuring compliance with standards, improving engine efficiency, and contributing to cleaner cities and healthier air for everyone.

### ENGINE POWER

Engine power, whether from internal combustion or electric motors, is crucial for Vehicle performance, acceleration, and efficiency.





# TYPE APPROVAL OF THE MAIN UNECE REGULATIONS

## CYBERSECURITY

With the rise of connected and automated Vehicles, cybersecurity has become essential to protect vehicle data, electronic control systems, and passenger safety.

The UNECE regulations, (UN Regulation No. 155 and 156), set strict requirements to prevent unauthorized access, cyberattacks, and tampering with vehicle software and networks. Compliance with these regulations ensures that Vehicles are not only safer and more reliable but also meet international standards, reducing risks and vulnerabilities in modern mobility.



## INSPECTION BODY

ATS Group is an inspection body accredited by the Italian accreditation body "Accredia" in accordance with the ISO/IEC 17020:2012 standard.

As an inspection body, ATS Group exclusively carries out conformity assessment activities and is therefore a third-party organization.

The inspection body must ensure that all inspections are conducted with impartiality, independence, and competence.

At the conclusion of the inspection phase, the body issues a final inspection report in which the activity records are documented, indicating whether or not they comply with a standard.

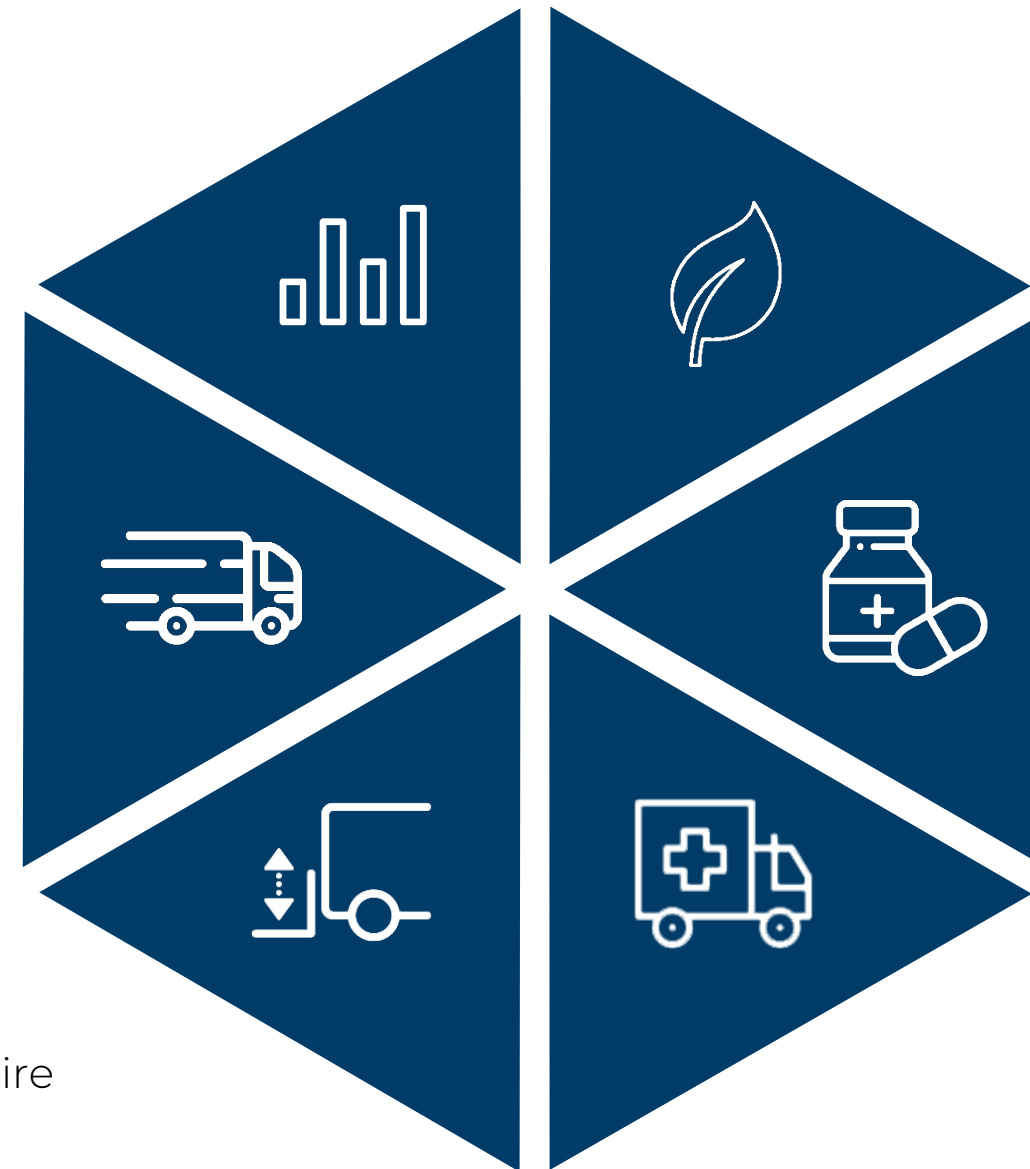

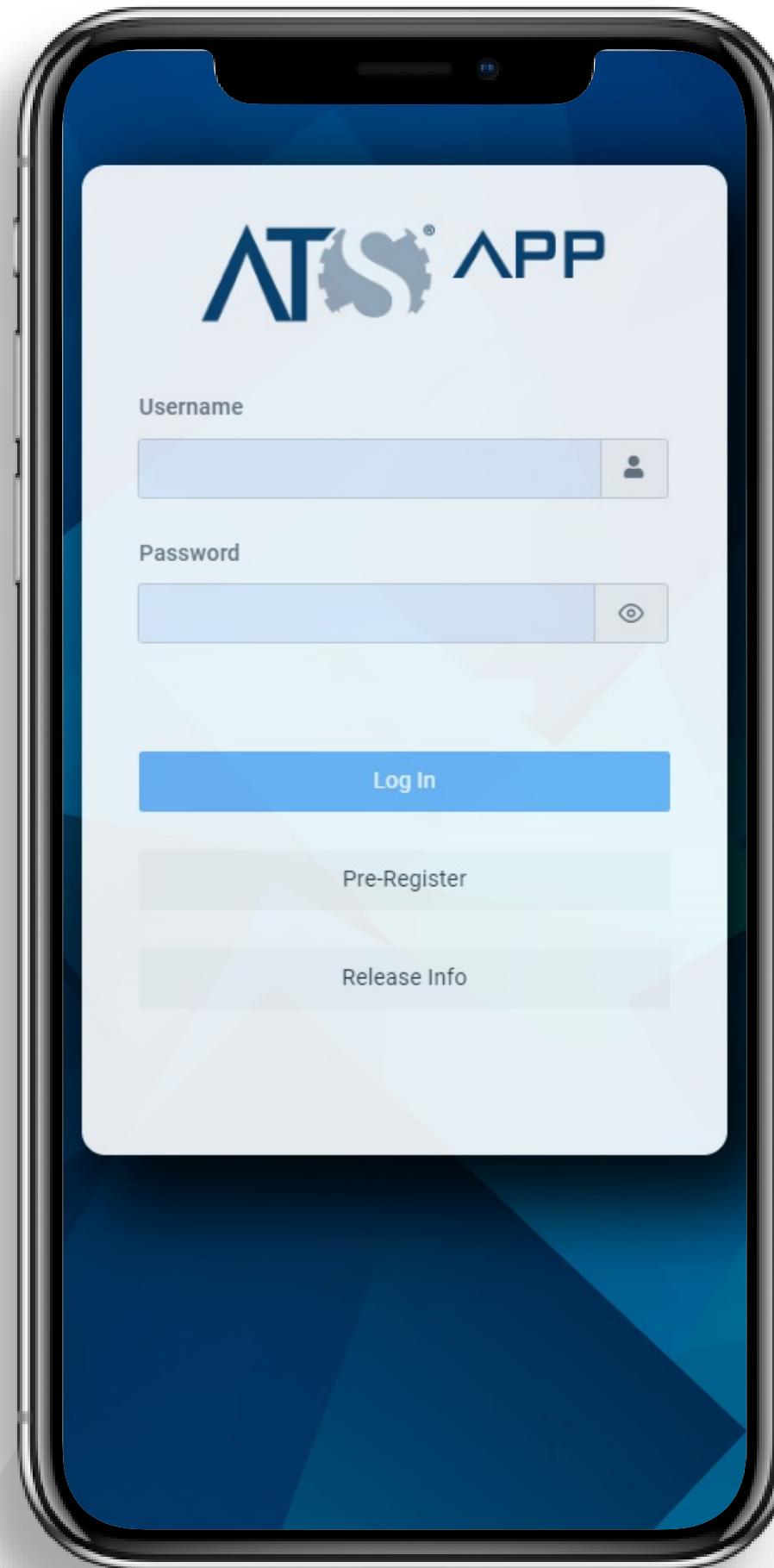

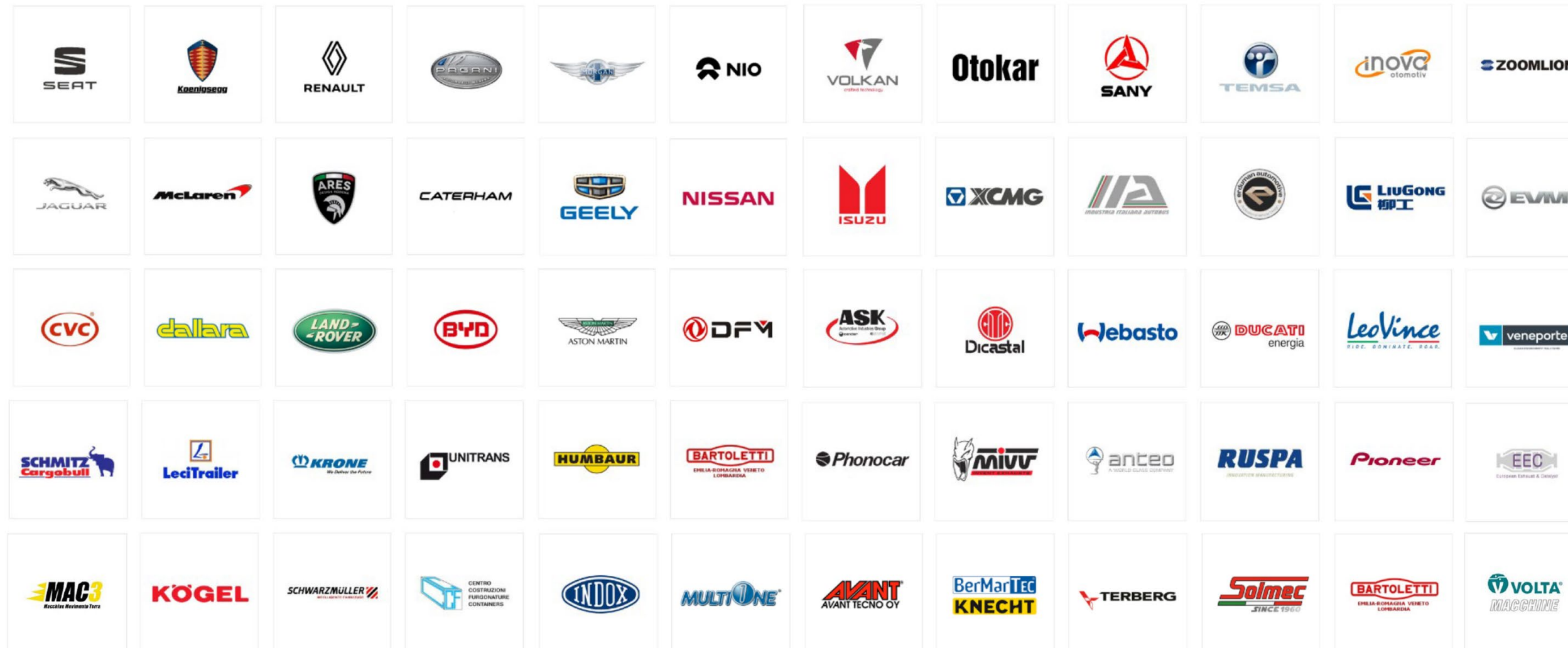
