REVALIDATION: STANDARDS TO REFLECT ON

In your second year of revalidation, you will need to submit four CPD records, a peer discussion record and a reflective account record. You can find out more about what these activities are and how to record them well on the GPhC website.

Reflective account

In your reflective account, you will need to explain how you have met one or more of the <u>standards for pharmacy professionals</u>. You will need to:

- explain briefly about your area of work (the setting of your practice and your main roles)
- explain us briefly who the typical users of your service(s) are
- explain how you meet the standards for pharmacy professionals we have selected for that year
- give a real example(s) taken from your practice to illustrate how you meet the standards we have selected

The standards you will need to reflect on are:

- standard 3 pharmacy professionals must communicate effectively
- standard 6 pharmacy professionals must behave professionally
- standard 9 pharmacy professionals must demonstrate leadership

You will need to reflect on one or more of these standards in your reflective account.

The GPhC have chosen these standards because:

they are important right now to assure members of the public that their trust in you is well placed

- they relate well to one another, so it's easier to provide a single reflective account on all three if you want to do that
- they used standard 3 in their revalidation pilot study, so evaluating reflective accounts based on this standard will help us evaluate how revalidation is working

Exceptional circumstances

Please remember that if you cannot make your submission deadline for this year because of exceptional circumstances, you should fill in an exceptional circumstances form in myGPhC as soon as possible, so you can avoid being asked to carry out remedial measures.

This might be because of sick leave, maternity leave, military postings, breaks from practice and possibly other reasons. Usually, if you have a good reason, you will still be able to renew your registration without submitting your records.

If you cannot submit all your records, the GPhC may be able to accept the records that you can complete. If there are gaps in your records like this, they should not normally be more than 12 months. In other cases, they might be able to give you an extension so that you can submit all your records at a later date.

THE ENGAGEMENT OF WOMEN IN PHARMACY

PDA Chairman Mark Koziol led a State Backed Indemnity Session that highlighted the key things pharmacists need to know about indemnity.

In a session titled 'GP Practice Pharmacy, everything you need to know about safer practice, but were too afraid to ask', Alima Batchelor, PDA Head of Policy and Liz Brooke, PDA Primary Care Pharmacist, shared their expertise and helped pharmacists to consider ways to practice more safely.

A recurring theme of the presentation was the need for pharmacists in general practice to work within their competency. As the number of pharmacists working within this sector has increased, the PDA has noticed an upturn in queries from this group, in line with our predictions.

We utilise our expert legal, employment and professional teams to provide the best support possible for members; in many cases we can show that what our member did was justified. From analysis of recent cases, we are finding a lack of appreciation for developing the necessary experience and competence required to take on the responsibility for prescribing and particularly diagnosing conditions.

Regulatory organisations and senior NHS bodies in a small number of cases are questioning the competence of the pharmacist to undertake the duties they were involved in.

We are therefore advising all pharmacists currently involved in, or considering a move into diagnosis and prescribing (the highest risk activity both from a patient safety and an liability risk perspective), to dedicate some time to reflecting on their experience and training and

identifying which areas they feel competent to practice in and which areas require further training or additional support from another clinician.

The PDA believe that the following incidents we outline suggest that consideration of competence and training needs is essential and will be time well spent for the pharmacists involved, not only to protect patients but to avoid the stress and trauma which invariably accompany regulatory investigations.

- Pharmacist returning to general practice after a break of several years referred to the pharmacy regulator by the employer due to allegations of errors and near misses whilst carrying out audits, medicines reconciliation and clinics.
- Pharmacist working on a locum basis investigated by NHS England for providing evening clinics from a branch practice with no doctor available on the premises for clinical supervision.
- Pharmacist with limited general practice experience providing patient facing care as part of triage service identified as potential risk to patients by a regulator requiring further investigation.
- A Pharmacist with no prior general practice experience taken on to provide minor ailment clinics. When asked about an unrelated health issue, an unchaperoned examination took place resulting in a minor problem being erroneously diagnosed. Patient subsequently placed on urgent 2-week wait pathway and diagnosed with cancer.

THE LAUNCH OF THE ENGLISH DEPRESCRIBING NETWORK (EDEN)

We were delighted to launch the national English Deprescribing Network at the Clinical Pharmacy Congress in June. The Chief Pharmaceutical Officer of England, Keith Ridge described how the creation of this network coincides with work going on to address overprescribing in the NHS and how healthcare professionals passionate about reducing inappropriate polypharmacy should sign up to EDeN.

The co-chairs of EDeN, Cherise Gyimah and Emma McClay described how the network had been developed over the last year with key stakeholders working within academia, areas of policy and importantly, those working directly with patients in their day to day roles.

The network has three key aims:

- Connect like-minded healthcare professionals, researchers and policy makers
- **Share** educational tools, resources, good practice and evidence to support decisions
- **3 Drive** learning and behavioural change

The network is hosted on the FutureNHSCollaboration platform where subscribers are able to access key guidelines and tools to support deprescribing in practice as well as useful case studies and information about the emerging evidence base in this field. There is also an open discussion thread for all members to start discussions and respond to others' who have posted queries, issues or topics of debate on the subject of deprescribing.

Throughout the launch and in the weeks since, we have received a lot of interest and have signed up nearly 300 people to this network platform so far, in this way the network is becoming a very rich resource for all interested in helping the right people take the right medicines which they agree are right for them!
