James Regent: (22: 37) I have colour blindness and so often my classes at school only used colour to distinguish different items, it is a real problem!

Rachel Hanson: (22: 38) We just did a review of accessibility on one of our virtual classrooms and it came up with some really interesting issues that I'm sure apply to other formats

Christina: (22: 38) Rachel, what were the main points if you don't mind please?!

Zahra: (22: 38) It always seems to be an afterthought but should be a constant thought throughout

Vicky Johnson: (22: 38) my old company was great at thinking about accessibility but the company I am with now haven't really thought about it!

Donald H Taylor: (22: 38) Zahra - agreed

Abilasha: (22: 38) Zahra - well said! accessibility must be taken into consideration right



from the beginning

Katherine: (22: 38) I'm a designer who struggles with colour recognition, so that brings its challenges!

Kemi Labinjo: (22: 38) What themes came up @Rachel Hanson

Tom Pieroni: (22: 39) Public Sector Digital Accessibility regulations are very much helping make a dent in peoples misconceptions

Vicky Johnson: (22: 39) We at least should be providing closed captions/subtitles for anything that is covered over audio

Sandi Rodman: (22: 39) I always add captions when there's audio and consider visual disabilities

Michael Whittaker: (22: 39) we user articulate storyline and are working hard to add as much as we can accessibility wise, I hear it is not the best tool for this but is it a case of you improve it yourself or do people recommend other software

Madhu: (22: 39) there is no acknowledgement for disabilities in our courses

James Booth: (22: 39) please can you ask questions in the box under the slides to avoid them getting lost in the chat

Phil Stephenson: (22: 39) @Katherine, I know totally how you feel

Emma W: (22: 39) We've been looking into a plugin that would allow users to change the fonts, colours, and spacing across the site. We've had some feedback though, that people with visual impairment prefer to use a separate app that they use for multiple websites

Kim Ellis: (22: 39) be careful with background music as it can make some people find it hard to concentrate depending on their disability

Rachel Hanson: (22: 39) @Christina - things like ensuring there's closed captioning on the VC platform enabled, likewise transcript. Also the requirement to use a microphone will limit some people.

Katherine: (22: 39) Good to know it's not just me, Phil:)

Michael Whittaker: (22: 40) we can add closed captions, tab order, transcripts, text and headings for screen readers and alt text so we do all we can but on testing we still hear it can be improved

Kemi Labinjo: (22: 40) I think that there is confusion caused when we used the words accessibility design and inclusive design, there are overlaps but they are not the same thing.

Katherine: (22: 40) @Kim Ellis I have sensory processing issues and find it really hard to concentrate if background music is too loud

James Booth: (22: 40) wow so many inputs - thank you

Rachel Hanson: (22: 40) @christina also providing up front a tour of the platform and any tech requirements beforehand rather than verbally at the start.

Belinda Parish: (22: 41) society disables people, not the 'impairment' or 'disability' itself sorcha: (22: 41) @Belinda - perfectly summed up

Graham Hutchings: (22: 41) Totally agree @Belinda

James Booth: (22: 41) my disability occurs when I have to type

mohamed Tageldin: (22: 41) cognitive is the most subtle

Raf Dolanowski (Question and Answers Support): (22: 41) @Belinda. Very good point. The design of our day to day environments and information is what will define if a disability is an impairment.

Katherine: (22: 42) It's important to remember that not everyone discloses disability - I have several invisible disabilities and not everyone knows about them, so some people assume I'm non-disabled and don't need any adjustments

Raf Dolanowski (Question and Answers Support): (22: 43) @Graham. I think engaging with the community is a good way to go. I've run focus groups with people who had visual



impairments by reaching out to organisations who advocate for people with disabilities Sandi Rodman: (22: 43) I never thought of disability like that before, as being in the environment, not in the person.

Kemi Labinjo: (22: 43) @Belinda you're right, that why we need to design the interface and content in such a way that it doesn't disable learners, but gives them access regardless of their impairment

Kemi Labinjo: (22: 44) @Katherine good point that ppl don't always disclose their disabilities, but also some ppl don't even know about them

Christina: (22: 44) @Rachel, thank you! We did the 'tour' but not even thought about closed captions yet and how to do that.... Using adobe connect, any tips anyone? Chantelle H: (22: 44) @Belinda Totally agree.

Gemma: (22: 44) It's also doesn't support inclusion making different training material James Booth: (22: 45) this is what my typing looks like to me

Rachel Hanson: (22: 45) @christina - adobe connect have an add on - we are testing it, not massively hopeful!

Katherine: (22: 45) @Kemi Labinjo that's very true - I'm currently going through the autism diagnosis process in adulthood - I didn't always know about it!

Tom Pieroni: (22: 45) @Christina - the html client for adobe is much much better but early days for instructors. The roadmap for development includes closed captions, but won't be available for a while.

Tom: (22: 46) @Katherine it's a horrific process in my opinion. I got my diagnosis around 7-8 years ago and I'm still struggling to get any support

James Booth: (22: 46) one benefit of adobe connect is that it can be customised with extra apps to do closed captions etc

Yvie Armstrong: (22: 46) what are best fonts for Asian languages

Katherine: (22: 46) @Tom I've been on the waiting list for 2 years now - I've had an initial telephone assessment but it could be several months before my final assessment

Egle: (22: 46) Regarding fonts, what about serif vs sans serif?

Rachel Hanson: (22: 46) @james booth any specific apps?

Rory: (22: 46) I work for a firm which has in a plaque in our HQ reading 'it's not done until it's for everyone' and I couldn't agree more.

Emma W: (22: 47) @rory - in the third sector, we often say "nothing about us, without us" Brian Helweg-Larsen: (22: 47) @Rory what company? Just interested...

Tom: (22: 47) @Katherine Yeah, sounds about right. I gave up and just took it all into my own hands and spent a lot of time researching and looking for my own best fits and fixes

Sandi Rodman: (22: 48) I discovered that colour vision can also deteriorate with age, too Brian Helweg-Larsen: (22: 48) You could use [square brackets] as an alternative

Katherine: (22: 48) @Tom I can understand you giving up on it

Rory: (22: 48) @Brian Helweg-Larsen - I work for D2L. We're a learning company and platform provider. Brightspace is the platform.

Rachel: (22: 48) @Fiona in exams we used to underline scientific names as an alternative to italics

Rory: (22: 48) @yasmin elgen - thanks, we're very proud of it.

Joyce Wilson: (22: 58) Really interesting, I am learning a lot

Jayne Davids: (22: 59) I use Camtasia to add captions to my videos. I might use the automated service in You Tube but always check and edit as never 100% accurate

Emma W: (22: 59) re. hashtags - I was told before to always use title case so that automatic readers can pick up the word separation, i.e. #susanalbumparty vs #SusanAlbumParty

Tom Pieroni: (23: 00) great example, Emma. Ha! James Regent: (23: 00) @Emma W - this is hilarious! Donald H Taylor: (23: 00) Emma - yes, that's for sure:)

Emma W: (23: 00) Sadly a true example from Susan Boyle's team many years ago! Tom: (23: 00) another famous example is #nowthatchersdead - the LGBTQ+ community was distraught, they thought Cher had died

Brian Helweg-Larsen: (23: 00) "My favourite hobbies are eating my family and flowers" - missing punctuation!

Emma 2: (23: 01) the hardest thing I find with alt text is writing useful text... i.e., it could be a picture of something like a dog or a house, but the point of using the image isn't that it's a house, but it represents something else or illustrates a point. so I find it helpful to think about what the reader would miss if that image weren't there

James Regent: (23: 01) @Brian - a different problem, but also funny!

James Booth: (23: 02) some drag and drop features can be used with mouse and keyboard, but, not all

Donald H Taylor: (23: 02) Emma 2 - that's a good point, and something I have not given enough thought to

Emma W: (23: 02) Emma 2- really good point

Lucinda: (23: 03) We try to avoid 'click' because it isn't really applicable on phones and tablets, but really interesting to hear of another reason we shouldn't use it

Zahra: (23: 03) @Emma 2 - I've put my Alt Text describing the image and adding "representing..."

Rob Schumann: (23: 03) How can we make sure text is the correct size if being designed for use on mobile devices? 14pt works when printed on paper.

Donald H Taylor: (23: 03) Zahra - thank you. I'll do that in future

James Booth: (23: 03) wow, I have used click so many times in the past

Emma 2: (23: 03) it's especially bad when trying to explain complex diagrams that are added as image files (graphics, graphs etc)

Raf Dolanowski (Question and Answers Support): (23: 03) Using "select" is also more appropriate given people may be consuming on a touch device, were "click" is not relatable but "select" is.

Isaac: (23: 04) I should preface this with the fact that I always sim to make things



accessible. Now, I'm working on some IT training but the piece of software we're training for is impossible to navigate with a keyboard and screenreader. Do I still need to make the training useable with keyboard and screenreader? thoughts?

Raf Dolanowski (Question and Answers Support): (23: 04) A nice example of how accessible considerations improve the UX experience for everyone.
