

## BEWARE OF SCAMMERS

**There is only one official ETIAS website:  
[europa.eu/etias](http://europa.eu/etias)**

This is where the ETIAS application form will be available once the system is launched.

There are dozens of websites claiming to be the official ETIAS sites: they use the official EU logo, some even collect travellers' personal data. While it will be legal for the commercial intermediaries to apply on your behalf, make sure you use one that you trust: some may steal your personal data, passport number and credit card. They may also charge an additional fee for their services

**Commercial intermediaries will have to use the official ETIAS website – the only official channel – to apply for the travel authorisation on behalf of their clients.**

**Remember: ETIAS will only cost EUR 20 if you use the official ETIAS website to apply. Any additional charges will go to the intermediaries.**

# Coming from a visa-free country and travelling to Europe?

You will need an ETIAS travel authorisation

## WHAT IS ETIAS?

ETIAS travel authorisation is a new entry requirement introduced by the European Union. It applies to visa-free travellers entering any of these European countries:

## DOES ETIAS APPLY TO YOU?

If you come from any of the following [visa-free countries](#) or [territories](#), you will need to have an ETIAS travel authorisation. There are some exceptions to this rule though - make sure to check on the official ETIAS website [europa.eu/etias](http://europa.eu/etias) whether any of them apply to your situation.

## 8 THINGS YOU NEED TO KNOW ABOUT ETIAS

- 1. ETIAS is a new travel requirement:** if you come from one of the visa-free countries listed before, you will need to get a travel authorisation to enter any of the 30 European countries requiring ETIAS.
- 2. To apply for an ETIAS you will need:**
  - a passport valid for more than 3 months
  - an email address
  - to fill out an online form
  - to pay a 20€ fee
- 3. ETIAS is for short-term visits:** with a valid ETIAS travel authorisation, you will be able to stay in any of the 30 European countries for 90 days in any 180-day period.
- 4. Your travel authorisation will be valid for three years** or until the passport you used in the application expires, whichever comes first. You can use it for multiple entries.
- 5. You will have the right to appeal** if your ETIAS is refused, revoked, or annulled. The appeals will be handled by the authorities of the European countries requiring ETIAS.
- 6. ETIAS is not a visa:** you will apply for an ETIAS online, you do not need to go to a Consulate, your biometric data will not be collected, and it will be much faster and cheaper than getting the Schengen visa.
- 7. The European Union is not the first to introduce travel authorisations for visa free national:** similar travel authorisations are required by the United States, Canada, and Australia as well as the UK.
- 8. The system is not yet operational and no applications are collected at this point.**
