



OPPORTUNITIES



Pharmacies can no longer be dependent on the NHS for a sustainable future. Whilst embracing the full range of NHS services, they must also develop the non-NHS part of their income including self-care support and treatment, and private services. Embracing these strategies not only ensures a sustainable future for pharmacies but also presents a significant opportunity for companies to target pharmacies as they diversify their income streams and expand their offerings beyond traditional NHS services.

1|PHARMACY FIRST



More than nine in ten community pharmacies in England are offering the ground-breaking initiative, with the service making it easier and more convenient for people to access care. The service was announced as part of setting out how the £645 million investment pledged within the Delivery plan for recovering access to primary care would be used to support community pharmacy services.

2 | DEVELOPING ROLE OF PHARMACY PROFESSIONALS



Pharmacy professionals are anticipated to be much more actively involved in patient care in the future. They need to upskill on both consultation skills and clinical skills to support with the growing need to be comfortable in a clinical setting and being competent in providing additional services in the pharmacy. Additionally, the number of independent prescribers will continue to grow.

3 | PHARMACY INTEGRATION



Community pharmacy is to become further embedded as an indispensable part of the local health system. Local relationships between Local Pharmaceutical Committees (LPCs) and Integrated Care Boards (ICBs), and between pharmacy contractors and Primary Care Networks (PCNs) are critical. Community pharmacy must optimise all of the national and any locally commissioned services.

4 | EMBRACING NEW TECHNOLOGY



Only approximately 20-30% of pharmacies have automation to improve efficiency, allowing pharmacy professionals to focus on patient care and counselling.
