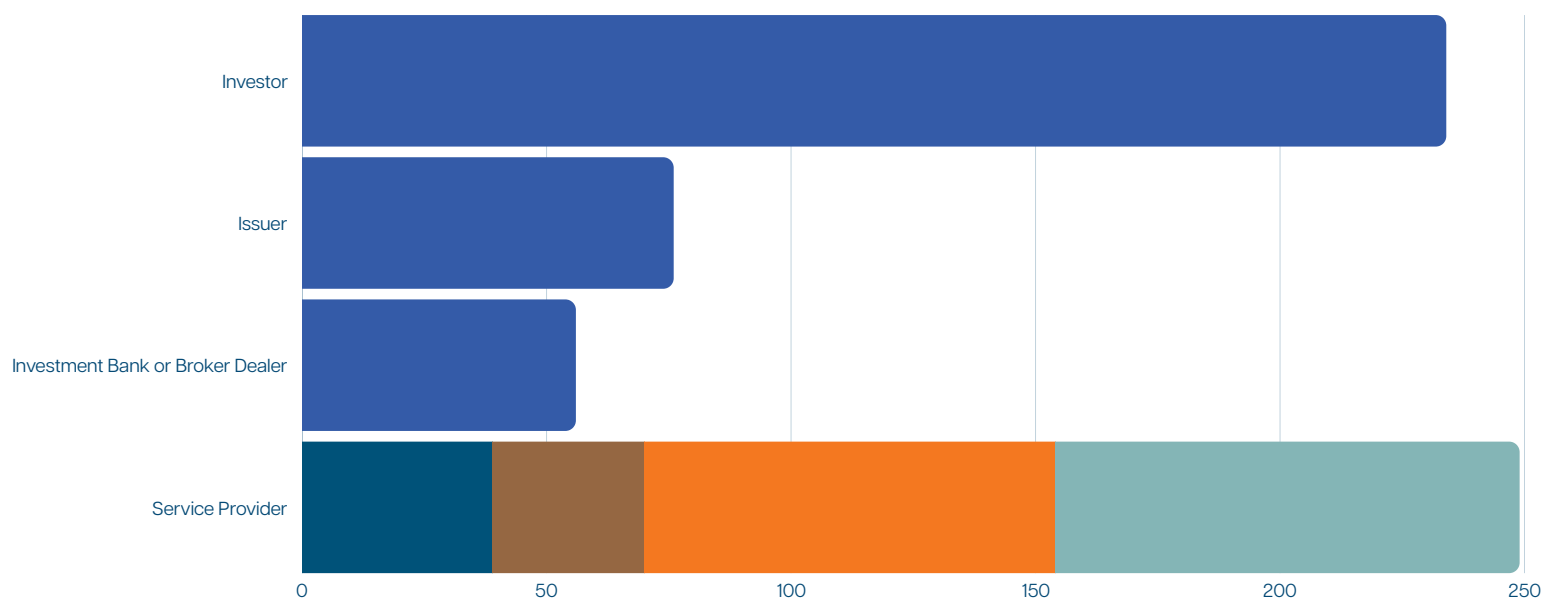

The inaugural Private Credit Connect: London made its mark by bringing together the key players in the private credit sector. Here's what made this event special:

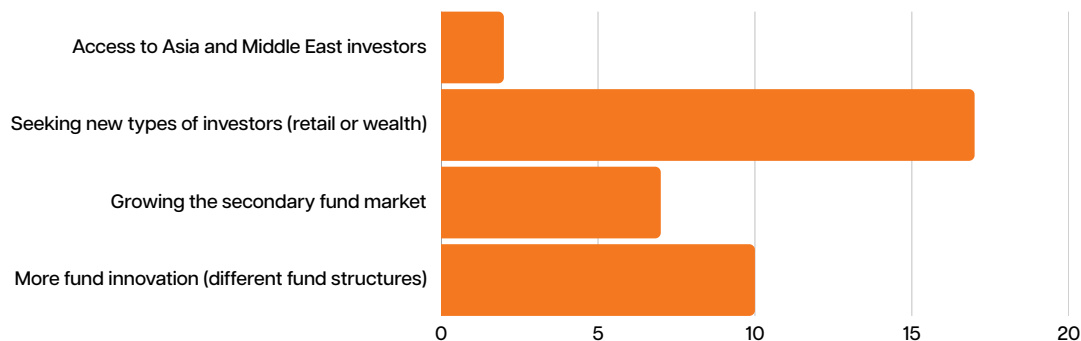
- Over 610 engaged private credit funds, investors, borrowers, and industry professionals registered to network, forge new partnerships, and propel the industry forward.

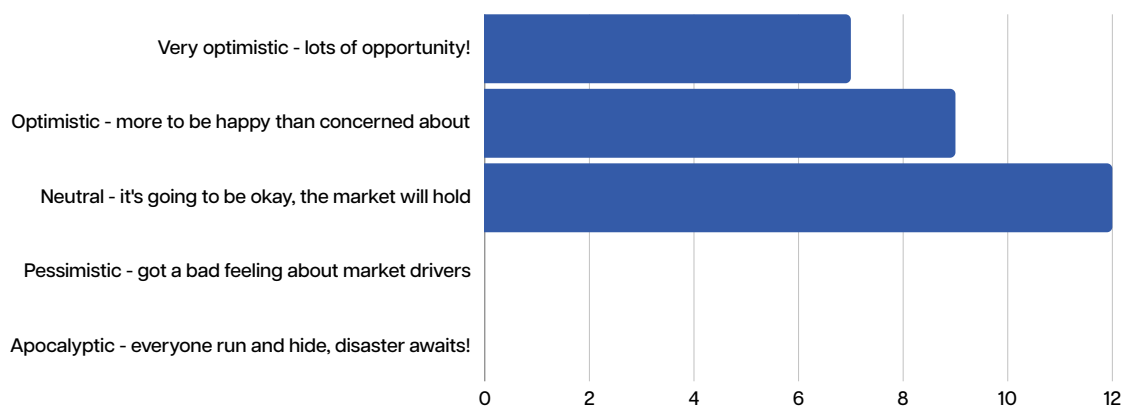

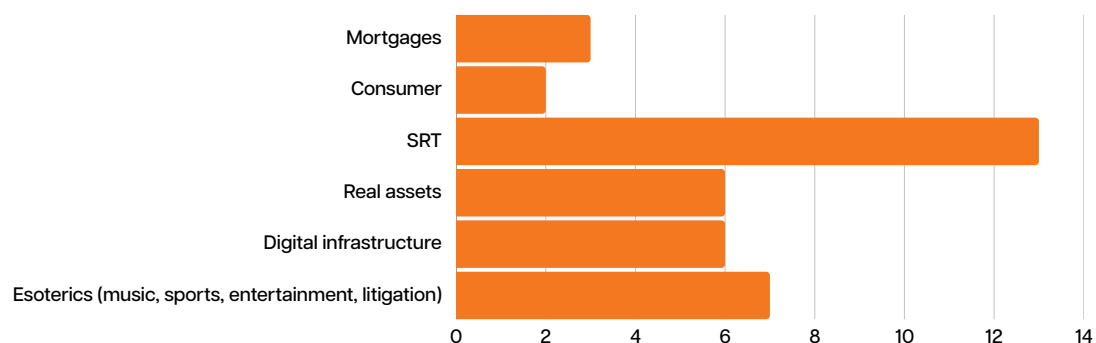
How will you grow your fund for the next 5 years?



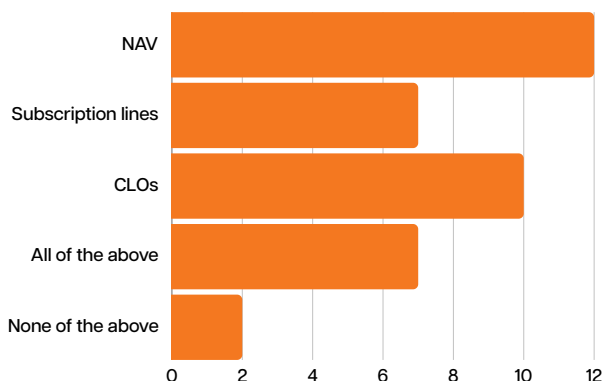
What's the market sentiment until the end of the year?



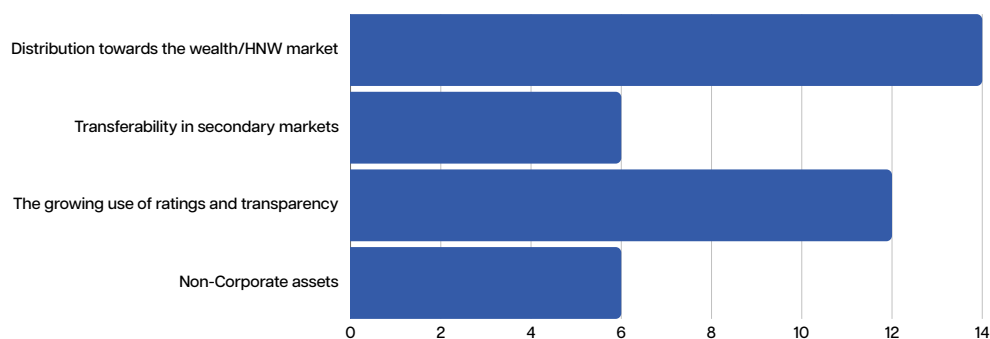

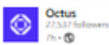

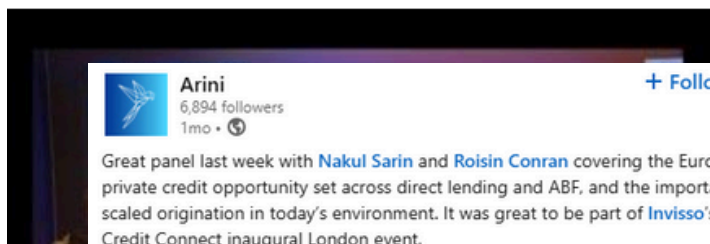
My key take aways from [Invisso's Private Credit Connect Conference](#) in London yesterday:

- ✓ Continued growth is expected in Europe's nascent private credit CLO market as there is strong investor demand. We can expect to see reinvesting private credit CLOs in Europe before long.
- ✓ Asset-based finance has the potential for significant growth. This area is attractive to investors as the relative returns are good, returns are uncorrelated and it offers diversity from corporate direct lending.
- ✓ The outlook remains positive for private credit direct lending. Sustained growth is expected in the short / medium term but likely at a slightly slower pace when compared to the huge growth seen in previous years.

On a personal note, it was a pleasure to moderate the "Breaking Ground in the European MM CLO Market" panel at yesterday's conference with great insights from the expert panellists.

Some key points which came up throughout the day:

- strong relationships between borrowers and lenders (especially in times of stress) is critical and has proven to be a key component in limiting defaults
- the market has proved resilient through high inflation, high interest rates, social and geopolitical events
- data collection and transparency is critical to the risk management environment
- LPs' appetite and requirements in relation to portfolio information continues to evolve and become more detailed
- deal flow requires detailed knowledge of local markets and local requirements

The Democratisation of Private Credit continues to develop and new products and new offerings will continue to come to the market. LTAF and ELTIF are important market developments and distribution networks will continue to be vital to their success.
