Future Mobility - Accelerating Mobility's Next Inflection Point

Spearheaded by the Roads and Transport Authority (RTA), Dubai's strategies for the future of its transport is headlined by its target for a quarter of all trips to be made by autonomous modes by 2030; with commuters served by up to seven autonomous modes. Since 2010, Israeli start-ups have been responsible for most of the tech breakthroughs in mobility, with over 300 of them attracting over \$18 billion in investments; placing Israel ahead of traditional automotive powerhouses Germany and Japan.
