Cookies Policy

1. INTRODUCTION

1.1 At Dubai World Trade Centre & its subsidiaries (hereinafter referred to as "DWTC," "us," "we," and "our"), we value your privacy, and we commit to stay transparent in using your data. This Cookies Policy is designed to provide you with clear information about how and why we use Cookies on our website. When you make your first visit to our official website https://www.dwtc.com/, you will have the option to grant consent or decline consent for the collection and use of Cookies.

2. WHAT ARE COOKIES?

2.1 Cookies are small text files that are stored on your device (computer, tablet, smartphone, etc.) when you visit a website. They are widely used to make websites work more efficiently and to provide information to the website owners.

3. WHY DO WE USE COOKIES?

- 3.1 Cookies help us in:
 - a. Managing and presenting the information displayed on our website.
 - b. Assisting you in navigating pages.
 - c. Analyse your use of our website.
 - d. Ensure that advertisements that you see on our website are according to your preferences and interests.
 - e. Assist us in understanding your preferences such as preferred languages as well as understanding our audience and analysing traffic patterns.

4. FIRST-PARTY COOKIES AND THIRD-PARTY COOKIES

- 4.1 First-Party Cookies are directly stored on your device when you visit our website. These Cookies enable us to gather analytics information, remember language preferences, and carry out other beneficial tasks that enhance your experience.
- 4.2 Third-Party Cookies are created by third parties like an advertiser. They are typically used for online advertising and are added by a script or tag to a website.

5. WHAT ARE THE TYPES OF COOKIES USED BY US?

5.1 Strictly Necessary/ Essential Cookies:

These Cookies are essential to enable you to move around the website and use its features. Without these Cookies, some of the website features may not provide the optimal results.

5.2 **Performance Cookies:**

Performance Cookies are generally third-party Cookies from vendors we work with or who work on our behalf that collect information about your visit and use of the DWTC website, for instance, which pages you visit the most often, and if you get error messages from web pages. These Cookies do not collect information that can be used to identify a visitor. All information collected by these Cookies is anonymous and is solely used to improve the functionality of the website. For example, we can use these Cookies to learn more about which features are the most popular with our users and which ones might need some revisions.

5.3 Targeting Cookies

Targeting Cookies are little pieces of information that we store on your system/ device. For example, if you have been browsing for conferences or webinars on our website, targeting Cookies helps us to remember your preferences, ensuring that when you return, we can provide personalised suggestions for upcoming events that align with your interests.

5.3 Unclassified Cookies

Unclassified Cookies are Cookies that are not used in the same category as other types of Cookies such as "First Party" or Third Party." These are usually set by websites you have previously visited, but also incorporate advertisement services or social media platforms.
