




Tanzania has ambitious plans to play an important part in connecting the region with several projects already in the pipeline.

Tanzania is strategically located in the region and is a member of EAPP and SAPP. Being a member of EAPP and SAPP, Tanzania is exposed to the power trading with nearby countries.

As a plan, Tanzania is expected to be a power hub in which regional power trading is important. Being bounded by eight countries, Tanzania is leveraged to import and export power within the region.

- 1. 400kV Tanzania Kenya Power Interconnector Project *Recently commissioned*
- 2. 400kV Tanzania Zambia Interconnector Project Construction Started
- 3. 400kV Tanzania Uganda Power Interconnector Project Under Feasibility stage
- 4. 400kV Tanzania Malawi Interconnector Project Feasibility is completed and solicitation of funds for project implementation is ongoing (approximate USD 54 Million)
- 5. 400kV Tanzania Mozambique Power Interconnector Project Under Procurement for Feasibility study
