



**National 4x4 and Outdoors Show  
Show and Shine Competition (“Competition”)  
Terms and Conditions of Entry**

**Introduction and Eligibility**

- 1 Information on how to enter and the prize details form part of these Terms and Conditions.
- 2 Participation in this Competition is deemed acceptance of these Terms and Conditions.
- 3 This Competition is operated in conjunction with the National 4x4 and Outdoors Show from 18 – 21 March 2022 (“Show”).
- 4 The Promoter is Exhibitions and Trade Fairs Pty Ltd, ABN 72 101 130 527 (“Promoter”) of 5/21 South Street, Rydalmere, NSW, 2116 (“Promoter’s Offices”).
- 5 Entry is open to persons who have complied with the How to Enter procedure and whose vehicle has been selected by the Promoter to participate in the Competition.
- 6 The Competition includes a major prize for the best in Show as well as best in Category.
- 7 The Competition Categories are as follows:
  - (a) Terrific Tourer
  - (b) Tough Tradie
  - (c) Urban Stallion
  - (d) Rough and Tumble(together “the Categories”).
- 8 The Promotion started by a call for entrants in January 2022 and receipt of entries closed on 11 March 2022 and shall end when the judges make and award the prizes. (“Promotion Period”).

**How to Enter**

- 9 To enter, participants must:
  - (a) have expressed interest to enter a vehicle in the Competition;
  - (b) have fully completed the entry form ;
  - (c) have attached a photograph of the entry vehicle and nominated in which Category the vehicle was to participate;
  - (d) have sent the completed entry form to the Promoter by 17 March 2022;;
  - (e) have been selected by the Promoter to participate in the Competition; and
  - (f) deliver the vehicle to the nominated area at the Brisbane Showgrounds on Saturday 19 March or Sunday 20 (as advised) and make the vehicle available for viewing by the general public attending the Show as well as inspection by the Competition judges.

**Prizes, Determination of Winners and Notification**

- 10 The Promoter accepts no responsibility for any late, lost, incomplete, misdirected, incorrectly submitted, delayed or illegible entry forms, claims or correspondence whether due to error, omission, alteration, tampering, theft, destruction or otherwise.
- 11 This is a game of skill, chance plays no part in determining the winners.
- 12 Each vehicle entered will be individually judged (by the judges, being representatives of the Promoter) based on, among other things:
  - (a) the extent of modifications carried out to the vehicle
  - (b) the functionality of the modifications carried out on the vehicle
  - (c) the look and aesthetics of the vehicle
  - (d) the uniqueness of the vehicle
- 13 The judges' decisions are final and no correspondence will be entered into.
- 14 By entering this competition entrants:

- (a) consent to the Promoter making copies of or publishing the whole or any part of their entry form and otherwise exploiting the entry and any rights in relation to the entry, to publicise this competition or for any other purposes; and
- (b) undertake to the Promoter that their entry form is not, and its use by the Promoter will not be, in breach of any third party intellectual property rights.

- 15 Judging will take place during the Show by a panel of judges appointed by the Promoter
- 16 The best vehicle in Show, as determined by the judges, will win the major prize.
- 17 The best vehicle in each Category, as determined by the judges, will win the Category prize.
- 18 The major prize is a set of Monster Offroad Wheels. The major prize is valued at approximately \$2,000 (inc GST).
- 19 Each best in Category prize is \$250 cash.
- 20 The total prize pool is valued at up to \$3,000 (inc GST).
- 21 The winners will be notified in person at the Show or failing which, in writing and by telephone.
- 22 The Promoter may require winners to provide proof of identity, proof of age and proof of residency at the nominated prize delivery address. Identification considered suitable for verification is at the Promoter's discretion.
- 23 The winners must, at the Promoter's request, participate in all promotional activity (such as publicity and photography) surrounding the winning of the prizes, free of charge, and they consent to the Promoter using their name and image in promotional material.
- 24 Prizes are not transferable or exchangeable and the major prize cannot be redeemed for cash. In the event for any reason a winner does not take the prize or an element of the prize at the time stipulated by the Promoter then that prize or element of the prize will be forfeited by the winner and cash will not be supplied in lieu of the prize. The Promoter accepts no responsibility for any variation in prize value. Where a prize is unavailable for any reason, the Promoter may substitute for that prize another item of equal or higher value as determined by the Promoter.
- 25 Each prize must be claimed by 15 April 2022. If a prize remains unclaimed by that date, that winner's entry will be deemed invalid and the Promoter reserves the right to distribute the prize to the next best valid entry that has not already received a prize.

#### **General Matters and Exclusion of Liability**

- 26 The Promoter reserves the right to verify the validity of entries and entrants, and disqualify any entrant who wishes to participate in the Competition in a manner not in accordance with these Terms and Conditions or who tampers with the entry or judging process.
- 27 The Promoter may, in its sole discretion, disqualify all entries from, and prohibit further participation in this Competition by, any person who tampers with or benefits from any tampering with the entry process or with the operation of the Competition or acts in violation of these conditions, acts in a disruptive manner or acts with the intent to annoy, abuse, threaten or harass any other person.
- 28 The Promoter and its associated agencies and companies will not be liable for any loss (including, without limitation, indirect, special or consequential loss or loss of profits), expense, damage, personal injury or death which is suffered or sustained (whether or not arising from any person's negligence) in connection with this Competition or accepting or using any prize, except for any liability which cannot be excluded by law (in which case that liability is limited to the minimum allowable by law).
- 29 Without limiting the previous paragraph, the Promoter and its associated agencies and companies will not be liable for any damage in transit to prizes.
- 30 These terms may contain prize offers from individual Show exhibitors and other persons who are not related companies of the Promoter. Subject to any applicable law which cannot be excluded, the Promoter makes no warranties or representations regarding the availability, quality, accuracy, merchantability or fitness for purpose of the goods or services offered as prizes. Your entering this competition and obtaining of goods or services from exhibitors or other persons is at your own risk. All prize information and other information concerning the prizes is provided by exhibitors and other persons and we advise you to confirm pricing and other details with the exhibitors and other third parties for the most accurate information about personal and other expenses, availability. You indemnify the Promoter against all liability, loss, damage, cost and expense arising from or relating to your obtaining goods or services from exhibitors and other persons offering prizes in this Promotion.
- 31 The Promoter accepts no responsibility for any tax implications arising from the prize. The winner should seek independent financial advice as to such implications.
