

NATIONAL 4X4 OUTDOORS SHOW - MELBOURNE
CONTENT CREATOR SCAN AND VOTE TO WIN PROMOTION
TERMS AND CONDITIONS

INTRODUCTION

- 1 Information on how to enter and about the prize forms part of these Terms and Conditions. Participation in the National 4x4 Outdoors Show, Melbourne ("Show") Content Creator Scan and Vote to Win Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.
- 2 The Show is held from 21 – 23 August 2026 at the Melbourne Showgrounds.
- 3 The Promoter is Exhibitions and Trade Fairs Pty Limited, ABN 72 101 130 527) ("Promoter") of Unit 5, 21 South Street Rydalmere, NSW ("Promoter's Offices").

ELIGIBILITY

- 4 Entry is open to Australian Citizens and Permanent Residents residing in Australia who have purchased a ticket to enter the Show ("Eligible Entrants"). Employees of the Promoter or its associated entities and agencies and their immediate family members are not permitted to enter.

PROMOTION PERIOD

- 5 The Promotion commences at 9 am on 21 August 2026 and ends at 3pm on 23 August 2026. ("Promotion Period").

HOW TO ENTER

- 6 To enter you must:
 - a. visit the Content Creators vehicle display area near the Boulevard Pavillion; and
 - b. using your mobile phone scan the Content Creator QR code; and
 - c. complete your contact details (name, phone and email) when prompted by the QR code; and
 - d. vote for your favourite vehicle/s. You may vote for up to 3 vehicles, you may only vote once.
- 7 Your vote will be entered into the draw to win the prize. If you vote more than once duplicate votes will be removed from the draw.

PRIZE and PRIZE DRAW AND DRAW DETAILS

- 8 The prize is supplied by LOVELLS AUTOMOTIVE SYSTEMS PTY LTD, ABN 82 139 985 603 and consists of a 50 litre LSP Lithium Bluetooth Portable Fridge Freezer valued at approximately \$999 including GST.
- 9 The QR codes will be located at Content Creators vehicle display area near the Boulevard Pavillion at the Show. If you vote more than once, duplicate votes will be excluded as an entry to the random draw.
- 10 The prize winner will be selected by a random draw.
- 11 If a prize (or any part of a prize) is unavailable due to reasons beyond the Promoter's control, the Promoter may substitute the prize (or part of it) with a prize of substantially equal value and/or specification.
- 12 The draw will be conducted electronically and will take place at 10am on 27 August 2026 at the Promoter's Offices. The first eligible entry drawn will win the prize.

WINNER NOTIFICATION

- 13 The winner will be notified in writing by email within 7 days of the draw. The prize must be claimed within **one month**. The prize winner's name (once verified) will be published on www.4x4show.com.au.

UNCLAIMED PRIZES

- 14 A draw for any unclaimed prize will take place at 10 am on 28 September 2026 at the Promoter's Offices, subject to any directions of a regulatory authority. The winner (if any) will be notified by email and phone and their name published on www.4x4show.com.au.

PRIZE COLLECTION/DELIVERY - OTHER DRAWS

- 15 Subject to paragraph 14, the Promoter will contact the prize winner to obtain a delivery address (if applicable) and confirm the contact phone number in Australia. The Promoter or prize supplier may at its discretion arrange to deliver the prize to the prize winner or require the prize winner to pick up the prize from the Promoter's or prize supplier's nominated address.

PRIVACY

- 16 The Promoter will collect personal information ("PI") from each entrant in order to conduct this Promotion and may disclose this PI to regulatory authorities, the prize supplier and relevant third parties, including its related entities, agents and the Promoters. Subject to any applicable law which cannot be excluded, the Promoter and prize supplier give no warranty or make no representation regarding the availability, quality, accuracy, merchantability or fitness for purpose of the goods or services offered as the prize.
