

**NATIONAL 4X4 OUTDOORS SHOW - SYDNEY**  
**\$10,000 ADVENTURE UPGRADE PROMOTION**  
**TERMS and CONDITIONS**

**INTRODUCTION**

- 1 Information on how to enter and about prizes form part of these Terms and Conditions. Participation in the National 4x4 Outdoors Show, Sydney (“Show”) Scan to Win Promotion (“Promotion”) is deemed acceptance of these Terms and Conditions.
- 2 The Show is held from 12 – 14 June 2026 at the Sydney Showground.
- 3 The Promoter is Exhibitions and Trade Fairs Pty Limited, ABN 72 101 130 527) (“Promoter”) of Unit 5, 21 South Street Rydalmere, NSW (“Promoter’s Offices”).

**ELIGIBILITY**

- 4 Entry is open to Australian Citizens and Permanent Residents residing in Australia who have purchased a ticket to enter the Show (“Eligible Entrants”). Employees of the Promoter and the Prize Suppliers or their associated entities and agencies and their immediate family members are not permitted to enter.

**PROMOTION PERIOD**

- 5 The Promotion commences at 9 am on 12 June 2026 and ends at 4pm on 14 June 2026. (“Promotion Period”).

- 6 To enter you must visit each Prize Supplier’s stand and scan the Supplier’s QR code and complete your contact details (name, phone and email) with each QR code. The QR codes will be located at 5 Prize Suppliers exhibition stands at the Show.
