



Exhibitor Liability Insurance Requirement

April 3 - 5, 2022 | Boston Convention & Exhibition Center | Boston, MA

Each exhibitor is required to carry at his/her own expense, Commercial General Liability insurance with limits of at least \$1,000,000 per occurrence, \$2,000,000 aggregate. If the exhibitor is providing alcohol beverages, liquor liability should be included. Such policy shall name the Massachusetts Restaurant Association, Exposition Development Company, Inc., the Boston Convention & Exhibition Center, and Freeman as additional insured. This insurance must be in force during the lease dates of the event, April 3 - 5, 2022.

The purpose of this insurance is to provide liability coverage for your company as well as for Show Management. You may obtain this insurance from your organization's own insurance company, or from the insurance company of your choice. For further details, refer to item #10 of your Exhibit Space Application & Contract.

Neither Show Management nor their agents are responsible for any loss or injury that may occur to the person or property of exhibitors or their guests, invitees, employees, or agents from any cause whatsoever, including cancellations or impediments to the conduct of the event. The exhibitor, on signing the contract, expressly holds harmless and releases the aforementioned from any and all claims for such loss, damage, or injury. The exhibitor agrees to pay for any damage (incurred through carelessness or other cause by the exhibitor, his employee, or agents) to the exhibition building, its equipment, or to that of another exhibitor. If the exhibitor's material fails to arrive, the exhibitor is still responsible for his space rental.

The exhibitor assumes entire responsibility and agrees to protect, indemnify, defend, save, and hold harmless New England Food Show and its agents, officers, and employees against all claims, losses, and damages, including attorney's fees arising out of our caused by:

- 1.) Exhibitor's installation, removal, maintenance, occupancy, or use of exhibition premises or a part thereof.
- 2.) The use of any patents, trademarks, copyrights, or other rights owned or possessed by a third party.

EXHIBITOR GENERAL LIABILITY INSURANCE

Such policy shall name the Massachusetts Restaurant Association, Exposition Development Company, Inc., the Boston Convention & Exhibition Center and Freeman as Additional Insured. This insurance must be in force during the lease dates of the event, April 1-7, 2022.

- Protects exhibitors who do not have Commercial General Liability Insurance or who do not want to use their own insurance
- Protects foreign exhibitors whose insurance will not pay claims brought in U.S. courts
- Cost is USD \$80 per exhibiting company - regardless of booth size
