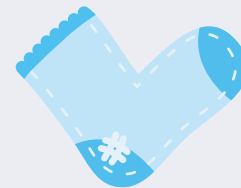
Even though using fresh eggs is more expensive and requires intensive care and coordination, we take care of these matters to ensure the best outcome for intended parents.

Premium Care for Surrogate Mothers



Safe personal space

Surrogate mother lives separately with her own child in a comfortable rented apartment during the program.



Zero alcohol and smoking tolerance

We don't allow behaviour which causes risk to the baby, and strictly monitor the surrogate mother's healthy lifestyle.



24/7 monitoring and care

Surrogate mother is under constant care of her personal coordinator.



Monthly financial support

We pay monthly payments to the surrogate mother, provide her with necessary medication and make sure that all of her needs are met.



Double medical checkup

We carry out two thorough medical examinations of the surrogate mother, once when adding her to our database, and again immediately before the start of the program.



Psychological testing and observation

A candidate for a place as a surrogate mother undergoes mandatory psychological testing. A personal coordinator monitors her emotional state during pregnancy.

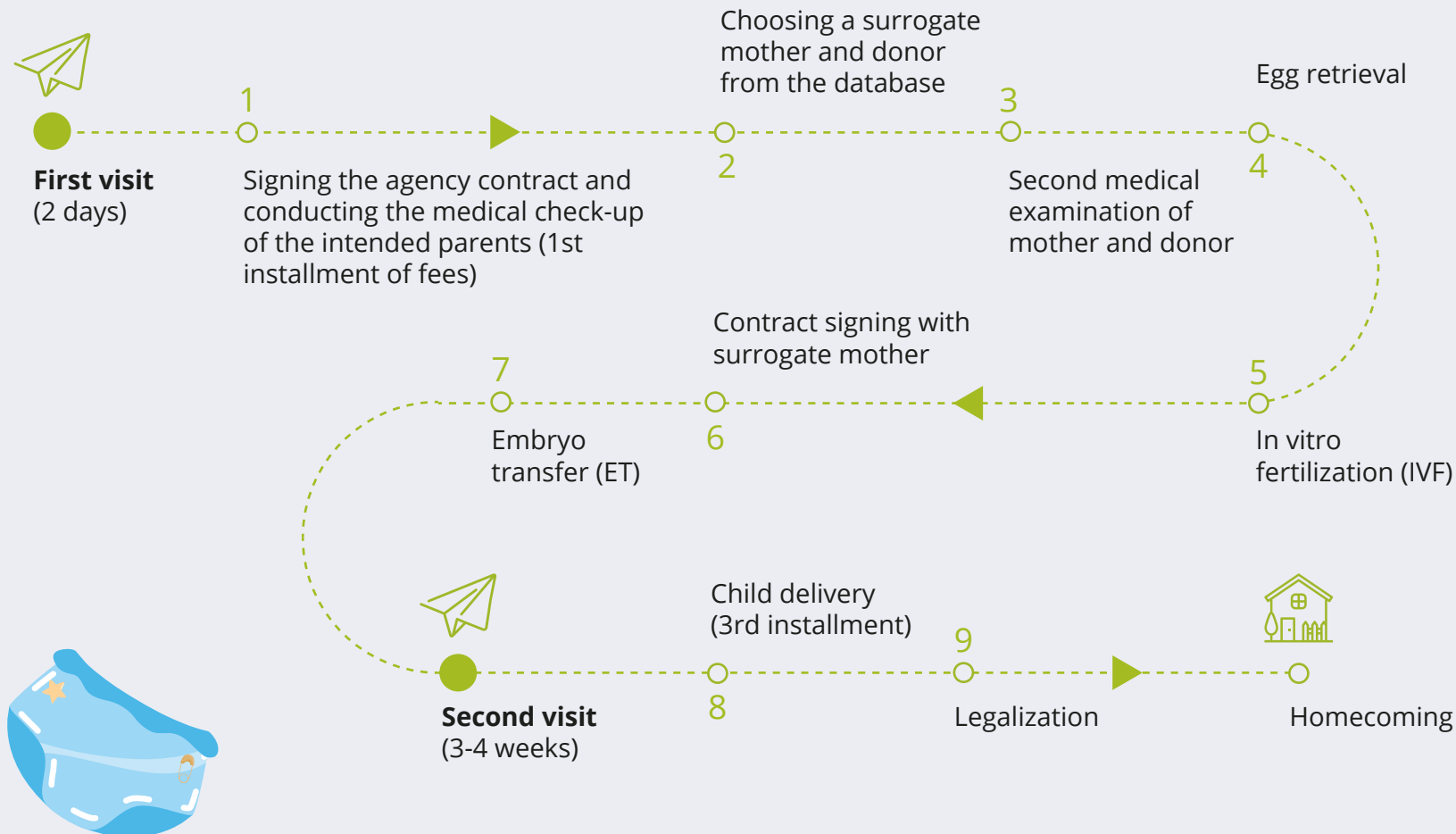


Legal support

All backgrounds are accepted

Russian law does not prohibit or restrict the implementation of surrogacy programs based on marital status, gender or sexual orientation.



Predictable procedures

Surrogacy is fully legalized and regulated by Russian law, all processes are clearly defined.

Agency provides an interpreter, notarization and translation of all required documents, as well as payment of all state fees, assistance in obtaining a passport, and a transit visa for a baby. **No extra charges for legalization procedures needed.**

Transparent payment terms

All fees are clearly stated in the contract. Intended parents are fully protected from any unexpected hidden costs or budget overruns.



Convenient payment schedule

The total sum is divided into three installments of different amounts, which are paid after the signing of the contract, after confirmation of pregnancy, and after the birth of the child.

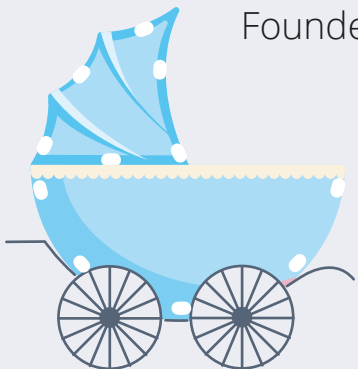
