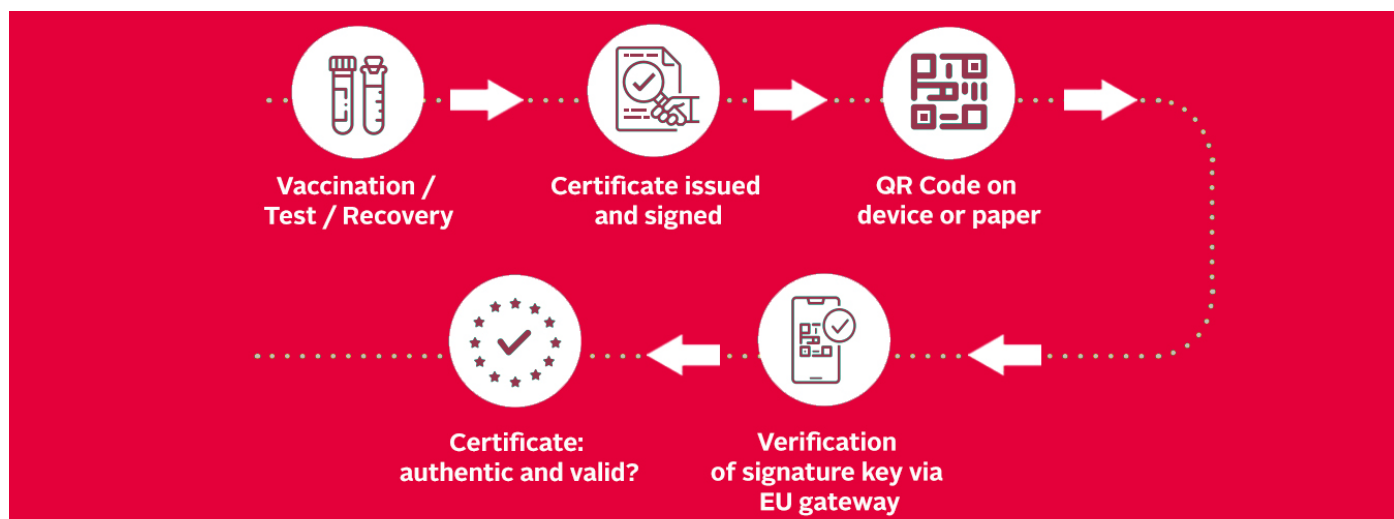
RAI Amsterdam event entry conditions

If you want to visit an event in the RAI, firstly you must be registered for that event and you will need a EU digital Covid Certificate (DCC). You will receive this digital certificate if you have been tested negative, have been fully vaccinated or are recovered from Covid-19. For people from outside of Europe we accept a proof of vaccination on paper as well.

Pay close attention to the website of the event you are going to visit to make sure if you are required to have the EU Digital Covid certificate.

How you can obtain this certificate varies per country. For example, it can be obtained from the test centres, the health authorities, or through an e-health portal. The national health authorities of the countries provide the information on how to obtain the certificate.

The digital version can be accessed via an app or stored on a smartphone or tablet. You can print a paper version. Both versions contain a QR code with essential information and a digital signature that guarantees the authenticity of the certificate.

All European member states use the same model of the electronic and paper version to facilitate recognition.



Testing for Entry (Testen voor Toegang)

If you have not yet been (fully) vaccinated and you have no proof of recovery, you must be tested to gain entry to the event.

If you are already in the Netherlands and have Covid-19 symptoms, do not come to the event. You can then get tested at the GGD (Dutch Regional Public Health Services).

If you don't have symptoms, you can get tested at a "Test for Entry" location. There are test locations throughout the Netherlands, these locations can be found on the website www.testenvoortoegang.org. Don't get tested more than 24 hours before the end time of the event.

Health questions

In addition to your test result, you will also be asked to answer five questions about your health.

If you answer all of these so-called triage questions with "no", you will get access to the event.

Privacy

No personal data is stored by RAI Amsterdam. However, you can be asked to show your ID. The test result is linked to your ID. This will be checked to be sure that the test result is yours.

Corona restrictions

With a valid entry ticket you can now attend the event. General Corona guidelines remain in effect. Keep 1.5-metre distance, (when there is no fixed seating) and disinfect your hands regularly.
