As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, April 14-17, 2025, naming Fortem CC Inc. (1 Newark Street Unit 20A Hoboken, New Jersey 07030) as the certificate holder. The following must be listed as additional insured: Fortem CC Inc. and Las Vegas Convention Center.
