



## Legal framework



# LOCAL CONTENT: Law 2019-04 of february 1<sup>st</sup>, 2019

LOCAL CONTENT IN THE HYDROCARBONS SECTOR REFERS TO ALL THE INITIATIVES TAKEN TO PROMOTE THE USE OF NATIONAL GOODS AND SERVICES AS WELL AS THE DEVELOPMENT OF WORKFORCE PARTICIPATION, TECHNOLOGY AND DOMESTIC CAPITALS THROUGHOUT THE OIL AND GAS INDUSTRY VALUE CHAIN.



## Classification of oil and gas activities

Decree 2020 – 2065 of october 28<sup>th</sup>, 2020 sets the terms for the participation of Senegalese investors in Senegalese companies involved in oil and gas activities and classifies these upstream oil and gas activities in the exclusive, mixed and non-exclusive regimes.

**Exclusive**: Activity of supplying goods and services that the national private sector is able to carry out immediately in compliance with the standards of the oil industry.

**Mixed**: Activity linked directly or indirectly to oil and gas operations requiring a significant level of technological maturity and specialized expertise, which the national private sector could carry out immediately in partnership with a foreign company.

**Non-exclusive**: Activity related directly or indirectly to oil and gas operations that the national private sector is not able to carry out immediately in compliance with the norms of oil industry standards.

**The exclusivity authorization** concerns activities for which the State of Senegal, with the aim of reducing the quantity of imported goods and services, reserves the right to grant authorizations for exclusive services, subject to a guarantee of quality of service and price controls.

### B - Institutional framework:

### **CNSCL: Steering Committee**

- Coordinate the implementation of the local content strategy document
- Define the modalities of execution of the strategic orientations of the State of Senegal in terms of local content
- Ensure, among other things, compliance with all the measures to which companies operating directly or indirectly in the hydrocarbon sector are subject.



## Technical Secretary: Operational entity

- Implementation of the local content strategy developed by the CNSCL
- Ensure the application of regulatory rules related to Local content in transparency and in the best interests of Senegalese companies
- Enable a better participation of Senegalese companies across the entire oil and gas value chain.

Maximizing local content in the supply of goods and services throughout the oil value chain
