


The Opening Keynote set a clear and confident vision for Abu Dhabi's future, positioning the Emirate as a city that does not merely adapt to change, but actively shapes it.

**H.E. Mohamed Ali Al Shorafa**, Chairman of the Department of Municipalities and Transport (DMT), emphasized that Abu Dhabi's rapid growth in population, investment, and ambition is deliberate, planned, and guided by leadership. Growth, he noted, is never left to chance.

A central message of the keynote was the rejection of the traditional trade-off between growth and livability. While many global cities accept congestion, strained services, and declining quality of life as inevitable consequences of expansion, Abu Dhabi views growth and livability as mutually reinforcing. Infrastructure was positioned as the critical enabler that allows both to advance together.

The address reaffirmed the government's mandate to build one of the world's most livable and lovable cities while maintaining global economic competitiveness, underscoring that neither objective is achievable without world-class, future-ready infrastructure. In this context, ADPIC highlighted the launch of more than AED 66 billion in transformational infrastructure projects, with further major investments planned for 2025. The keynote also linked infrastructure to the UAE's Year of Community, framing roads, utilities, and urban systems as tools that connect people to opportunity, strengthen neighborhoods, and create a more human-centered urban experience.

The address concluded with a call to action, positioning ADIS as a working platform for collaboration and delivery, and inviting partners to help shape Abu Dhabi's future for generations to come.

The Opening Address marked the launch of the inaugural Abu Dhabi Infrastructure Summit (ADIS), positioning infrastructure as a strategic force that shapes society, unlocks economic potential, enhances quality of life, and prepares future generations for success. ADIS was introduced as a global platform established under the direction of Abu Dhabi's leadership to convene decision-makers, innovators, and investors committed to reimagining infrastructure as a driver of transformation.

**His Excellency Eng. Maysarah Mahmoud Salim Eid**, Director General of the Abu Dhabi Projects and Infrastructure Centre (ADPIC), framed ADIS as a response to the most pressing challenges facing modern cities, including climate resilience, rapid urbanization, digital transformation, and inclusive growth. While complex, these challenges were presented as opportunities for cities willing to adopt bold, collaborative, and human-centric approaches to development.

A central theme of the address was ADPIC's role as a translator of vision into delivery. Beyond project management, ADPIC oversees the full lifecycle of strategic capital development across housing, healthcare, education, culture, connectivity, and public spaces. In 2024 alone, ADPIC delivered more than 11,000 homes, reduced build times by up to 40% through modular construction, and achieved emissions reductions of approximately 30%. The address emphasized that success in infrastructure is measured not by scale alone, but by human impact, strengthening identity, improving everyday life, and creating opportunity for future generations. Looking ahead, His Excellency unveiled ADPIC's five-year strategic roadmap, reinforcing commitments to sustainability, innovation, partnership, and large-scale adoption of modular construction.

The address concluded with a call to global partners to engage with Abu Dhabi as a city where vision meets execution and long-term impact is delivered through collaboration.

The panel discussion highlighted Abu Dhabi's vision to become the world's most liveable city by using infrastructure as a catalyst for economic growth and social well-being. Moderated by CNN's Becky Anderson, the conversation emphasized that infrastructure is not limited to just concrete and steel, but must encompass how people live, move, and access essential services like education and healthcare.

**H.E. Mohamed Ali Al Shorafa**, the Chairman of the Department of Municipalities and Transport, explained that Abu Dhabi's urban planning is driven by the principle of making the city both "livable and lovable," and further elaborated on how planning is tailored to diverse communities, with each district assessed based on demographic needs and livability factors. He stressed the importance of aligning infrastructure with economic strategy, saying the city must be ready for new business clusters and population growth.

**H.E. Ahmed Jasim Al Zaabi**, the Chairman of the Department of Economic Development, shared key data: a 200% increase in foreign investment over the past decade and significant growth in the construction sector, and positioned infrastructure, including smart city initiatives and legal readiness, as integral to attracting global investment. Abu Dhabi, he noted, has never received a credit downgrade – further reinforcing its stability and long-term appeal.

The second panel of the day brought together key voices from government, investment, tourism, and real estate to explore Abu Dhabi's holistic approach to lifestyle-focused development. Moderated by Becky Anderson, the discussion centered on how Abu Dhabi is moving beyond traditional real estate models to create vibrant, human-centric communities that meet the evolving expectations of residents, tourists, and investors.

**H.E. Dr. Saif Sultan Al Nasri** emphasized Abu Dhabi's resident-first mindset, where nationals and residents act as co-creators of the emirate's future. He outlined the government's unified planning strategy, balancing top-down vision with bottom-up community engagement to design spaces that prioritize wellbeing, safety, and livability.

**H.E. Badr Al Olama** discussed how Abu Dhabi Investment Office measures returns beyond finance, focusing on economic diversification, long-term partnerships, and resilience. He highlighted the government's agility in adapting regulations to keep Abu Dhabi attractive for global investors while maintaining a high quality of life.


# Abu Dhabi: The Capital of Lifestyle Development

Panelists agreed that Abu Dhabi's coordinated approach, spanning infrastructure, policy, entertainment, and culture, positions it as a global benchmark for future-ready cities. The “Global Infrastructure Partnerships: Collaborative Opportunities” panel, moderated by Gaurav Sharma Of Forbes Magazine, brought together leading voices in urban development and infrastructure to explore how Abu Dhabi is shaping the future through international collaboration. The conversation focused on sustainable growth, resilient infrastructure, and the importance of long-term partnerships between governments and private developers.

**Mounir Haidar**, reflected on two decades of transformation in Abu Dhabi, crediting the government’s vision and support for enabling developers to deliver not just real estate but integrated, livable infrastructure. He emphasized that infrastructure development is a creative and strategic endeavor, not just technical execution.

**Carlos Wakim**, advocated for a human-centric approach, explaining how Bloom Living was designed to foster well-being, walkability, and community cohesion across generations and nationalities, shifting the focus from investor demands to quality of life.

# Global Infrastructure Partnerships: Collaborative Opportunities for Transformative Development

**Fuat Kasimcan**, highlighted Turkey's contribution to global infrastructure, with \$540 billion in projects across 278 countries. He emphasized the importance of extending partnerships beyond finance, into innovation, technology, and knowledge-sharing, especially as the region pivots toward green and digital transformation.

**Abdulaziz AlObaidli**, discussed how Masdar has scaled renewable energy projects across the globe by working closely with local governments to co-create policies and ecosystems. He stressed the importance of ESG (environmental, social, governance) practices, community inclusion, and the long-term nature of infrastructure investment.

The panelists jointly agreed that Abu Dhabi's model of visionary planning, openness to innovation, and regulatory clarity makes it a global example of how infrastructure can be a platform for economic and social resilience.

The panel highlighted how Abu Dhabi is transforming into a world-class logistics and trade hub by integrating air, sea, land, and rail into a seamless, multimodal ecosystem. The discussion emphasized how logistics is no longer a backend operation but a strategic growth engine driving trade, economic resilience, and regional competitiveness.

**Omar Alsebeyi**, explained how the integration of ports, railways, roads, and inland terminals is enabling efficient, door-to-door movement of goods across the UAE, and that thanks to 900 km of track connecting key ports and cities, was also reducing truck traffic, cutting emissions, and unlocking scalable opportunities for cross-border trade, including a new \$1.5 billion rail link with Oman. He highlighted recent collaborations like the Etihad Rail–DHL joint venture as proof of the private sector's growing confidence in Abu Dhabi's logistics infrastructure.

**Hassan Al Hosani**, emphasized the importance of keeping infrastructure future-ready, pointing to AI and digital twins as critical tools for building predictive, integrated systems that monitor and optimize logistics performance in real time. With existing capabilities in roads, ports, and airports, Hassan argued that with automated warehouses and control centers poised to enhance operational efficiency, Abu Dhabi is well-positioned to be the region's logistics capital.

The panel concluded with a shared vision: to position Abu Dhabi as the region's central logistics hub, combining advanced technology, government support, and world-class infrastructure to attract global businesses and investors.

The panel explored how Abu Dhabi is transforming its approach to dispute avoidance in capital contracts, aiming to replace reactive litigation with proactive conflict management. Moderated by Hisham Al Zeir, the discussion showcased public sector reforms and the rise of structured dispute avoidance mechanisms in the UAE's infrastructure sector.

**Fatima Balfaqeeh** emphasized the shift from heavily amended and one-sided contracts to more balanced frameworks that encourage fairness and engineer neutrality, highlighting recurring issues in the sector such as delayed payments and unrealistic timelines, while she praised Abu Dhabi's moves to rebalance contractual powers and revive the role of the engineer in dispute prevention.

**Dr. John Fletcher of RICS** reflected on global learnings, particularly from the UK's evolution from arbitration to adjudication and to conflict avoidance. He introduced RICS' pilot project in Abu Dhabi to deploy Conflict Avoidance Panels (CAPs), designed to identify early warning signs and mediate before disputes escalate.





# Dispute Avoidance: Advancements in Abu Dhabi Capital Contracts

**Mahmoud Abu Hussein**, addressed why DABs (Dispute Avoidance/Adjudication Boards) are underutilized in the region, citing misconceptions around cost, time, and employer control. He underscored the role of the engineer and FIDIC's 2017 suite, which strengthens dispute avoidance and encourages a culture of neutrality and early resolution.

**Maria Mazzawi**, highlighted institutional contributions, noting the center's rapid growth and commitment to fast, enforceable, and user-friendly arbitration. She announced a new MOU with ADPIC to develop training programs and appointment mechanisms that support adjudication and dispute avoidance.



**Ir. Ricky C K Lau**, delivered a comprehensive overview of the city's progress, challenges, and forward-looking strategies in infrastructure development. Despite its dense urban landscape and geographical limitations, Hong Kong has positioned itself as a global leader in urban infrastructure, integrating innovation, sustainability, and resilience into its long-term planning.

Key achievements included world-class projects like the Hong Kong-Zhuhai-Macao Bridge, the Ching Ma Bridge, and its ranking as the #2 Global Financial Center for infrastructure. The city is leveraging its role within the Greater Bay Area and China's Belt and Road Initiative, serving as a bridge between mainland China and international markets.

To remain competitive, the Hong Kong SAR government is investing USD 15 billion annually in public works and prioritizing AI, robotics, and modular construction. Technologies like BIM, generative AI, automated inspections, and remote-operated cranes are being used to reduce design time by up to 70% and enhance construction quality and efficiency.

Hong Kong is also pioneering ultra-high-strength steel, achieving up to 35% material savings, and promoting green building standards through the BEAM Plus system. With over 620 collaborative projects already using NEC contracts and no recorded disputes, the city is promoting harmony in project delivery and stakeholder engagement. Talent development is a central pillar. Through initiatives like the Center of Excellence and partnerships with institutions like HEC Paris, Hong Kong is fostering leadership, innovation, and global recognition for its professionals.



While we have made achievements in infrastructure, Hong Kong still faces challenges, but by capitalizing on the strengths of Hong Kong, mainland China, and our international partners, we can build smart, green, and resilient infrastructure for future generations.

This panel brought together experts in AI, smart infrastructure, and modular construction to explore how digital technologies are shaping the future of urban development across the Middle East. Moderator Dr. Hesham Nour Eldeen opened the session by emphasizing that AI, modular construction, and smart city technologies are no longer buzzwords—they are actively reshaping the construction and infrastructure sectors, particularly post-COVID.

**Dr. Hesham Nour Eldeen** set the stage with questions about how AI can align with ethical standards and community needs, to which the panelists responded by highlighting strategies for inclusivity, transparency, and optimization through digital tools.

**Ghiya Al-Haj-Hasan**, discussed the role of AI and IoT in optimizing operations and sustainability. Buildings, she explained, are now intelligent ecosystems capable of learning and adapting in real time. Sensors track occupancy, energy, and environmental factors, allowing AI to enhance comfort, reduce energy use, and meet climate targets. She also emphasized the importance of partnerships and data-driven outcomes.

He stressed that modular does not mean generic, with the right digital tools and design flexibility, these systems can reflect local culture, materials, and community values. Collaboration with urban planners at early stages is key to integration and acceptance.

**Klemensas Mecejus**, addressed how public-private partnerships can thrive through shared access to technology and data. He argued that the public sector's untapped data reserves and the private sector's innovation, a collaboration between both can transform services, from smart infrastructure to predictive urban management.

In this engaging panel, Dr. Bilal Succar led a discussion on how Building Information Modeling (BIM) is a catalyst for digital transformation in construction and infrastructure. He emphasized BIM as the essential gateway to AI, digital twins, and modern project deliveries.

**Khadija Alrubaie** explained how Abu Dhabi Project Center (ADPIC) uses BIM across 60+ projects worth AED 64 billion, highlighting its role in accurate planning, budgeting, and anticipating change requests. She noted ADPIC's plans to mandate BIM and develop guidelines while addressing skill gaps through collaboration with universities and training programs.

**Khaled Awad** underscored BIM as a critical productivity tool beyond design clash detection, recounting his experience with BIM-enhanced assessments compared to challenges in outdated buildings lacking digital records. He called on government bodies to mandate BIM standards like ISO 19650 to drive ecosystem-wide improvements, training, and consistent adoption. The discussion candidly addressed barriers like resistance to change and skills shortages, concluding that BIM is essential for productivity, lifecycle management, and sustainable urban development in Abu Dhabi and beyond.



The panel explored global perspectives on “urban excellence,” with insights from architects, urban developers, and government advisors. Moderated by Gaurav Sharma, the discussion opened with a key question: how should cities define urban excellence? **Emre Arolat** advocated for a balance between economy, equity, and ecology—citing global examples like Paris and Amsterdam that use metrics and stories to shape humane, integrated urban systems.

**Greg Bargull** stressed the importance of social infrastructure—parks, gathering spaces, and walkability—as foundational elements of livable communities.

This engaging conversation explored how Modon Real Estate, under the leadership of Paul O'Brien, is redefining large-scale development in Abu Dhabi and beyond through sustainability, smart technology, and strategic partnerships. Moderated by Andrew Tuck, the session touched on Modon's city-scale planning philosophy and the integrated role of AI and innovation in shaping the built environment.

**O'Brien** explained that Modon operates with a “blank canvas” mindset, using its vast portfolio of 300 million sqm to embed sustainability and digital systems from the ground up. Projects like Hudayriyat Island are designed as full ecosystems-where infrastructure, public realm, and digital experiences are planned holistically. AI is already being used within operations to streamline reporting and decision-making, and it will increasingly personalize customer experiences through digital IDs and smart interfaces.

The conversation also addressed the importance of values-aligned partnerships. Modon seeks collaborators who share its ESG vision and can deliver quality at pace-an expectation sometimes difficult for international partners unused to Abu Dhabi's fast development cycles. Nevertheless, the company has successfully exported its model globally, with net-zero projects underway in Egypt and London.

O'Brien concluded by affirming that this is only the beginning. With the support of Abu Dhabi's leadership, Modon is just scratching the surface of what's possible in sustainable, scalable urban development.

**Mulham G. Kheriba**, underlined the importance of location and experience as key luxury attributes, describing Abu Dhabi as a natural luxury canvas with its islands and mangroves. He discussed their in-house development model, which allows for greater control and affordability, adding that for him, branded developments are not essential, but can enhance a product if grounded in functional design.

Architect **Kourosh Salehi** advocated for a people-centered definition of luxury rooted in livability, safety, and long-term value. He critiqued trend-based designs that prioritize style over substance and stressed that true luxury should enhance quality of life rather than mimic foreign models. Salehi also praised Abu Dhabi's unique identity and called for the region to lead rather than follow global trends.

The final panel of the day explored Abu Dhabi's unique approach to health and wellness infrastructure, highlighting the integration of culture, innovation, and inclusivity. Moderated by Razan Salman, the conversation featured H.E. Mohammed Alsuwaidi and Dr. Georges-Pascal Haber, both of whom emphasized how Abu Dhabi is setting new standards for wellness investment and healthcare delivery.

**H.E. Mohammed Alsuwaidi** explained that Abu Dhabi's wellness planning is deeply rooted in heritage and cultural identity, prioritizing long-term sustainability by investing in adaptable, scalable infrastructure while maintaining a human-centered governance model that engages the community at every step. In just a decade, Abu Dhabi has shifted from medical tourism outbound to a destination attracting thousands of patients from around the world. He noted the importance of AI, digital health, and longevity-focused models that are reshaping the healthcare paradigm. Importantly, he stressed that investing in advanced technologies for luxury markets enables scalability and democratization of healthcare access globally.

Both speakers agreed that Abu Dhabi's unique advantage lies in visionary leadership, world-class infrastructure, and inclusive urban planning, with wellness and livability at the forefront.
