

**Orange County Convention Center ("OCCC")Your COVID-19 Self-Declaration**

***If you will be attending InfoComm 2021 at the Orange County Convention Center ("OCCC"), June 11 through June 18, 2021, in any capacity, you must complete this Self-Declaration prior to admittance and bring it with you to gain entry.***

***THIS INCLUDES EXHIBITORS, ATTENDEES, PRESS, VENDORS, ANY PROVIDERS OF SERVICES AND THEIR STAFF, VOLUNTEERS, AND FAMILY. THERE ARE NO EXCLUSIONS OR EXCEPTIONS.***

I attest to the following:

1. Within the last 14 days, I have not experienced any of the symptoms related to COVID-19 nor have I taken medication to reduce fever during that time.  
Common symptoms include fever, cough, runny nose, shortness of breath or difficulty breathing, fatigue, muscle or body aches, headache, sore throat, nausea or vomiting, diarrhea and/or loss of sense of smell or taste. These symptoms do not include those attributed to another health condition that you normally experience. 2. Within the last 14 days, I have not tested positive for COVID-19.
3. Within the last 14 days, I have not been in close contact (being within six feet of an infected individual for at least 10 minutes) with an individual who has tested positive for COVID-19.
4. Within the last 14 days, Neither I nor anyone with whom I have been in close contact (being within six feet of an infected individual for at least 10 minutes) are waiting for results of a COVID-19 test.
5. Within the last 14 days, I have not cared for someone showing symptoms of COVID-19.
6. I am not under any self-quarantine orders.
7. I have understand that I will be required to wear a mask at all times while at InfoComm 2021.
8. I agree to fully comply with: (i) any health and safety protocols and mitigation measures implemented by the OCCC and/or AVIXA; and (ii) all local, state and federal requirements, each of (i) - (ii) as amended from time to time (collectively, the "InfoComm 2021 Attendee Protocols") while on the event grounds.
9. I agree that if my health should change while attending InfoComm 2021 at the Orange County Convention Center, I will immediately leave the event and facility and seek medical guidance.
10. I agree that if I test positive for COVID-19 or am exposed to someone who has tested positive for COVID-19, I will notify AVIXA promptly and will not reenter the Orange County Convention Center.
