Welcome

Welcome to Community Care Live 2024!

This year's event is a particularly special one as this year is Community Care's 50th anniversary.

Social work and social care have changed dramatically during that time. But the values that bring people into the sector and inspire their work have not.

We will be retelling social work's story since 1974 throughout the two days: in the special edition of Community Care magazine available at the event; in the exhibition depicting key milestones of the past 50 years; and through cartoonist Harry Venning's capturing of those.

Alongside this, the event will be bringing you its usual blend of invaluable learning, networking, the chance to explore new career opportunities and moments to recuperate and take stock.

We are delighted that the chairs of the national children's and adults' principal social workers networks will be kicking off the event.

We have over 30 sessions of free learning this year, with learning from lived experience a key theme.

Bestselling author and care experienced trainer Jenny Molloy will be returning to the event for a session on day two on working better with women who have experienced addiction and domestic abuse, speaking alongside two other experts by experience.

On day one, expert by experience and academic Rebecca Regler will deliver a session on why involving people with lived experience in social work's design and delivery is so important.

To round off day one, Chickenshed Theatre Company will perform 'Inclusion Emergency, a production that shares its members' experiences of social exclusion.

You can also take advantage of free seminars on learning from serious cases, building an anti-racist culture at work, supporting children involved in or at risk of violence, strengths-based practice with adults and understanding the benefits system.

And for occupational therapists, we have a dedicated learning stream on day one, with seminars on anti-oppressive practice, risk enablement and working with social workers.

We also have two sessions on self-care and supporting your own wellbeing, alongside chair yoga, mediation and relaxation in our dedicated wellbeing area.

In our paid-for legal stream this year, you can update your knowledge on areas including hoarding, care and support decisions and the Mental Capacity Act, the legal framework for adult safeguarding, protecting children from exploitation and private law proceedings.

None of this would be possible without the support of our exhibitors and, in particular, our sponsors: Essex County Council, our event partner, learning sponsor Hampshire County Council and our event sponsor, Wiltshire Council.

There are over 30 organisations exhibiting this year including employers from North West to South East England, providers, learning organisations and recruiters. Do take the time to go and talk to them in the exhibition, while catching up with colleagues over a coffee.



Frequently asked questions

Is there a fee to attend?

Community Care Live is offered free of charge to all registered social workers, local authority social care senior managers, commissioners or workforce leads, government ministers or senior civil servants, police officers, youth offending service staff, probation officers and final-year social work students.

Individuals who do not meet this criteria but would still like to attend will be required to pay the event delegate fee of £395 + VAT, during the online registration process or on site (payable by credit or debit card only).

In addition to our free seminar programme, our legal learning sessions carry a fee of £35+ VAT if booked in advance online or £40+VAT if you pay at the registration desk during the event days.

Can I pay by invoice for legal learning sessions?

No, payment is strictly by debit or credit card only.

I am a student; can I visit the event?

Free attendance is available for ALL social work and occupational therapy degree students and those in higher levels of education. Students in any other area of study will be required to pay the conference delegate fee.

Can I pre-book to attend sessions from the seminar programme?

All of our free-to-attend seminar sessions are available on a first-come, first-served basis only.







LIVED EXPERIENCE INVOLVEMENT IN SOCIAL WORK: WHY IT MATTERS AND HOW TO INCREASE **PARTICIPATION**

Co-production as a process is gaining popularity within strategic projects and service development. However, its principles and values can also be useful for increasing involvement within an individual's care and support. By reflecting on her lived experience and academic knowledge of co-production, Rebecca Regler will share why participation from people with lived experience is so important and how it can be increased at a strategic and individual level. People with lived experience are experts in their own lives and that expertise - combined with professional expertise - can lead to better outcomes.



Strengths-based social work is a deceptively simple approach that's been conflated with community strengths-based models, causing confusion for practice. This has led to the reductionist question 'what are your strengths' now being seen as an acceptable basis for assessment.

But it may also be that in the face of overwhelming need, a simplistic approach to assessment serves the unconscious need to contain anxiety for social workers and wider system.

For any safeguarding system to be able to learn about how well it's doing, it needs good feedback about the processes and the outcomes of the services provided. However, reviews often adopt a deficit focus, and practitioners are often the focus for blame when a tragedy occurs. Where this leads to more compliance measures and defensiveness, we're not creating the conditions for workers to do what they do hest.

Donna will explore how this can be different and how the review process can adopt a strengths-focused analysis, geared around learning from what went well, encouraging openness and ownership rather than leading to more compliance measures and defensiveness.









