Why do you need us?

It is simple really... Failure to fulfil your legal obligations to ensure the safety of individuals in the event of a fire can result in enforcement action, including fines and custodial sentences.

Fire safety in England and Wales is governed by the Regulatory Reform (Fire Safety) Order 2005. You may have heard it referred to as the Fire Safety Order. This order came into force in 2006 and applies to most buildings, except single private dwellings. The Responsible Person must ensure that a competent person is appointed to assist them with managing fire safety, starting with a Fire Risk Assessment.

Following the Grenfell tragedy, new legislation has been introduced, aimed at improving building fire safety. This includes:

- The Building Safety Act 2021
- The Fire Safety (England) Regulations 2022
- Fire Safety Act 2021
- Amendments to the Fire Safety Order

A common misconception is that these new legislations only apply to high rise residential buildings; whilst there is a significant amount of change for these buildings, there are requirements for all buildings.

Are you the Responsible Person?

You are the Responsible Person (RP) if you are the owner, occupier or an employer that occupies a building. The RP is not always an individual, it may be an organisation. A highrise residential building will also have an accountable person (AP), who has additional responsibilities.

As the RP you must ensure that suitable and sufficient fire safety precautions are implemented, managed and monitored. The best place to start is by appointing a competent person to assist with fulfilling your duties under the fire safety order, which includes appointing a competent person to carry out the fire risk assessment.

Fire Safety Management Procedures

The Fire Safety Order requires that the RP manages fire safety within their premises and documents how this will be achieved. You must plan, manage, monitor and review your fire safety procedures.

The Responsible Person should Plan fire safety protective and preventative measures using the outcomes of the fire risk assessment and document to produce a fire safety management policy and procedures document. You should state how you will manage the provision of information and training to relevant persons, protective and preventative measures,

Evacuation plans and emergency procedures, Maintenance, testing and inspection of your fire safety measures, Measures for vulnerable persons, and a system for the monitoring and review of your fire safety procedures. Detail how you will monitor your fire safety arrangements and how often and by what means you will Review the effectiveness of your arrangements. Fire Risk Assessment is intrinsic to this process.

Emergency Evacuation Plans

The RP must plan how to execute an effective and safe emergency evacuation in the event of a fire. This document consists of a site plan and a written procedure that plans what people should do in an emergency, including: raising the alarm, contacting emergency services, exit routes, muster points, assisting occupants to evacuate, accounting for missing persons, and other aspects of an emergency evacuation. In a more complex building, you may need assistance with producing your plan.

Fire Plans & Premises Safety Information Boxes

If you are responsible for a multi-occupied residential premises, you will need to plans of your premises, which show the fire safety provisions, such as risers, portable fire fighting equipment, and final exits. You may also require a premises safety information box. There are specific contents that are required to assist the fire and rescue service. We can provide these facilities for your premises.

Fire strategy & Design

Buildings under refurbishment, extension or construction are required to comply with Building Regulations. If you are working on a project where you must comply with the Building Regulation, you should take competent advice on how to incorporate fire safety guidance, such as Approved Document B, BS9999 or BS999, in order to fulfil requirements B1-B5 of the Building Regs.

A fire consultant can review your designs and provide you with a fire strategy report on how to achieve compliance. We can work with your architect to reach solutions that comply, are safe and consider cost implications. Should your designs be complex, we can facilitate a fire engineered solution.



Fire Risk Assessments
