


# Discover IBFD's eBooks

An eBook is a digital version of a traditional print book. eBooks can be downloaded and read on a variety of devices, including personal computers and mobile devices such as smart phones, eBook readers and tablets.

## 1. Table of Contents

The table of contents is accessible from every page. By tapping a section, you are taken straight to it. By turning the tablet on its side, you can have a two-page view.

## 2. Bookmark a page


Tap the bookmark icon in the top right corner to bookmark a page. A red bookmark will appear as shown. Bookmarks are stored in a central place. By tapping on the bookmark you are taken back to the section where the bookmark was made.

## 3. Search dictionary

Tap twice on a word to look up its definition in the dictionary or search the web.


## 4. Scroll function

Scroll quickly and easily through the book using the scroll function at the bottom of each page.

### 5. Set font – font size – screen brightness

Tap the letter icons in the top right corner to change the font and font size. The screen brightness can also be adjusted by moving the scroll bar sideways.

### 6. Store notes

Notes are stored in a central place. By tapping on the note you are taken back to the section where the note was made.

### 7. Highlight – select – copy

Select text by moving your finger over it. Different options will then appear that allow you to copy and highlight text, add a note or search for the selected text elsewhere in the book.

### 8. Look up text

Tap the magnifying glass in the top right corner and a search bar will appear allowing you to search the entire book.
