Member case studies:

Surrey Fire and Rescue Service

The senior leadership team at Surrey Fire and Rescue Service approached the IFE after it implemented professional approaches to specific areas of its business. They found that professional status could be found in roles within legal, HR, IT and procurement but that it was less prevalent in operational and fire specific roles. The team wanted to change this and worked closely with the IFE to create their membership, resulting in the majority of staff becoming IFE members and in turn ensuring all their employees had a place within an appropriate professional body, no matter what their role. The result has impacted the overall service, with employees gaining professional recognition which has raised standards of professionalism and practice across Surrey Fire and Rescue Services, directly benefitting the community it protects.

London Building Control

London Building Control (LBC) wanted to enrol their staff via Corporate Account Membership to provide individuals with personal professional recognition whilst enhancing the company's professionalism overall. There was a desire for staff to become more aware of fire safety and upgrade their knowledge and qualifications, as well as have the opportunity to mix with other professionals within the sector, which is provided through IFE events. Working with the IFE, a membership package has been created to meet all of LBC's requirements and resulted in 50 employees being enrolled.
