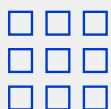

S2S Group are setting targets to tackle the goals that are most relevant to the business

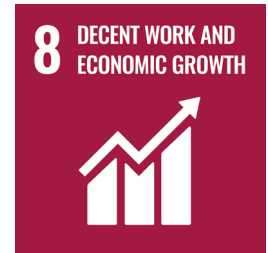
