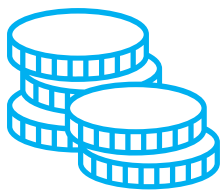

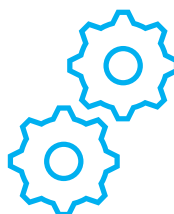

The CyberAscend framework...

Because CyberAscend is embedded into our DNA, it is a key part to all our services. Every engagement follows this lifecycle, ensuring our clients receive consistent, repeatable and effective cyber security that grows with them over time.

Rather than treating cyber security as a one-off activity or a set of disconnected tools, CyberAscend embeds continuous improvement into the way an organisation thinks and operates. It ensures our clients are not only protected today but are constantly strengthening their security posture as their business, risks and technology evolve.

Our CyberAscend approach is built around five interconnected stages:

1

Initiate - We start by understanding our clients: their business, their goals, and what truly matters to them. This allows us to align cyber security with business outcomes from day one, not bolt it on as an afterthought.

2

Discover - We identify risks, vulnerabilities and gaps across people, processes and technology. This discovery phase gives our clients a clear, honest view of where they are and how to get to where they want / need to be.

3

Remediate - Following the Discover phase, we provide detailed reports that evidence the weaknesses, provide advice on how to strengthen, to close off the initial project we host a debrief meeting. This is to review the outcomes, allow time for questions, advise on next steps. This ensures organisations are empowered to close the gaps, remove vulnerabilities, plan, and most importantly increase their security posture.

4

Confirm - In this stage, we are keen to understand how remediation is progressing, an opportunity for organisations to ask questions and verify that the steps they have or are going to take fall in line with the recommendations made in the report and debrief meeting. D2NA can provide additional support if organisations require expertise or manpower.

5

Continue - Cyber security is never “done”. We know that organisations need to continuously review, adapt and improve to stay resilient. Threats, regulations and the organisation itself never stop changing.



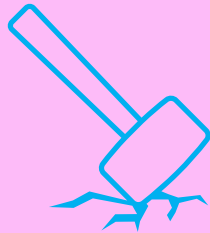
