# **Enhancing Storefront Security for a Luxury Retailer**

# Challenge

High-end retail stores are increasingly targeted by ram-raid attacks, posing significant risks to merchandise, property, and customer safety. Traditional security measures often clash with the aesthetic standards expected by luxury brands.

# Solution

To address this, Crowdguard implemented the Unafor Core system—a discreet, impact-rated Hostile Vehicle Mitigation (HVM) solution. This system offers robust protection against vehicular threats while maintaining the visual appeal crucial to premium retail environments.

#### **Implementation**

The Unafor Core units were strategically installed at the storefront, providing a physical barrier against potential ram-raid attempts. Designed with aesthetics in mind, these units seamlessly blend with the store's exterior, ensuring brand image remains uncompromised.

#### Outcome

The deployment of the Unafor Core system has significantly bolstered the store's defense against vehicle-borne threats. By integrating security with design, the retailer successfully enhanced safety without detracting from its luxurious storefront presentation.







# **Chester Races** *Case Study*

# **Spectator Safety at Chester Racecourse**

# Challenge

Chester Racecourse required a certified hostile vehicle mitigation (HVM) solution that could be rapidly deployed ahead of race meetings and fully removed outside of event hours. The goal was to enhance spectator safety without compromising the visual integrity of the historic venue. Traditional security measures had proven both challenging and time-consuming to install and de-rig, often clashing with the aesthetic and operational needs of the site. A more agile, visually sympathetic solution was essential.

## Solution

Crowdguard installed the Unafor Core HVM system - a semi-permanent, shallow-mount solution that provides certified protection against vehicle threats. With a compact 600mm profile and foundation depths from just 200mm, it offers strong security with minimal disruption. The system is fully removable, requires no heavy equipment to install, and can be customised to suit the racecourse's branding.

# Implementation

Unafor Core foundations were strategically installed around the racecourse. On event days, operatives simply insert the posts using a quick, click-and-lock mechanism—with no need for heavy machinery. The socketed design allows for rapid deployment and easy removal, ensuring that protective measures are in place only when needed.

# Outcome

This flexible, unobtrusive system enabled Chester Racecourse to maintain its daily operations without disruption, while delivering the certified protection required during high-attendance events. The solution also preserved the historic character of the venue, blending safety with sensitivity to the surrounding environment.







# **Bradford City Centre Case Study**

Regenerating and Protection ahead of City of Culture 2025

# Challenge

As part of its regeneration plans and preparations for becoming the 2025 UK City of Culture, Bradford needed to pedestrianise key areas in the city centre while ensuring robust protection from vehicle-borne threats without disrupting the visual or functional integrity of the space.

## Solution

Crowdguard partnered with Bradford Council, Sweco, and Balfour Beatty to deliver a bespoke Hostile Vehicle Mitigation (HVM) strategy. A combination of Unafor's removable and fixed shroud systems were installed in Centenary Square, providing certified protection with minimal visual impact and operational disruption.

# **Implementation**

Each location was assessed individually to meet specific operational needs. Removable systems were deployed where authorised vehicle access was required, while fixed systems secured high-footfall pedestrian areas. Installations were carried out with sensitivity to the urban fabric, aligning with Bradford's ongoing design and regeneration goals.

#### Outcome

Bradford now benefits from a safer, more accessible, and culturally welcoming city centre. The integrated HVM solution supports both everyday public use and large-scale cultural events, demonstrating how thoughtful security design can contribute to placemaking and urban transformation.
