His vision was ambitious: to create a structured pathway that would take new entrants through a three-year development journey, culminating in their qualification as fully-fledged fire safety inspectors. The programme included all necessary training elements, ensuring a comprehensive and practical learning experience.

Chris worked with one awarding body to develop the Introductory Certificate in Fire Safety, a qualification that laid the foundation for structured learning in the field. This pioneering course was later delivered through The Fire Safety Academy and adopted by multiple fire and rescue services across the UK as an opening to further development.

Chris credits much of his success to the encouragement and guidance he received from his two mentors, who, despite being competitors, provided invaluable advice and support. Their passing marked a profound loss, but their influence continues to inspire Chris in his mission to elevate fire safety training standards and educating fire safety professionals through his other connections in the Institution of Fire Engineers, where amongst other roles, Chris is a Fellow member and helps to process Engineering Council applications.

Through perseverance and dedication, The Fire Safety Academy quickly gained traction, securing contracts with fire services in Surrey, Gloucestershire, Manchester, Norfolk, and Warwickshire. While these courses were initially delivered in-house, their success provided the foundation for an ambitious expansion into Open Courses, making fire safety qualifications accessible to a broader audience.

Recognising the constraints and pressures faced by fire safety professionals, The Fire Safety Academy ensures that submission deadlines are more flexible, allowing candidates additional time to complete their work. This approach acknowledges the realities of working in the service and ensures that learning can be balanced alongside operational duties.

Additionally, The Fire Safety Academy offers one-to-one mentoring, flexible course delivery, and more digestible, bite-sized pre-course learning, ensuring that every candidate receives

the support they need to succeed. These provisions enhance the accessibility and effectiveness of the learning experience, making it easier for professionals to upskill while managing their workloads.

Beyond qualifications, The Fire Safety Academy also provides legal case preparation and training. Chris's extensive experience as a Senior Lead Fire Safety Inspector in Oxfordshire, and his expertise in legal casework is now channelled into specialised training, equipping fire safety professionals with the knowledge and skills to navigate difficult legal frameworks effectively.

Today, The Fire Safety Academy operates open courses in cooperation with the Kents Hill Park Conference and Banqueting Centre in Milton Keynes, offering a range of accredited courses. The current programme includes the Level 3 Certificate, Level 4 Certificate, and Level 4 Diploma in Fire Safety, with plans to introduce additional courses as demand grows. This initiative ensures that fire safety professionals from any organisation, not just fire and rescue services, can access high-quality training tailored to their specific needs.

Chris's commitment to continuous learning and professional development is evident in his own academic pursuits. Currently studying Building Engineering and Law, he continues to expand his expertise to enhance the quality and scope of training provided by The Fire Safety Academy. Chris is also working with Skills for Justice Awards and the Home Office to draft new qualifications in Fire Risk Assessment.
