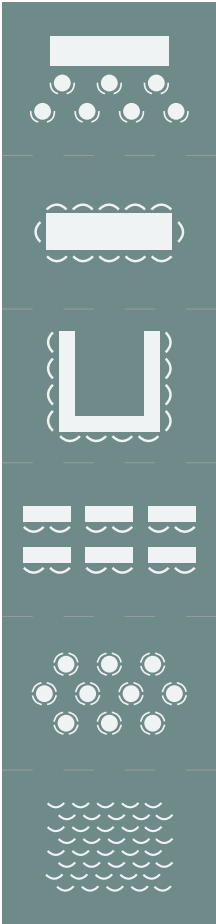


WELCOME TO THE MANOR HOTEL

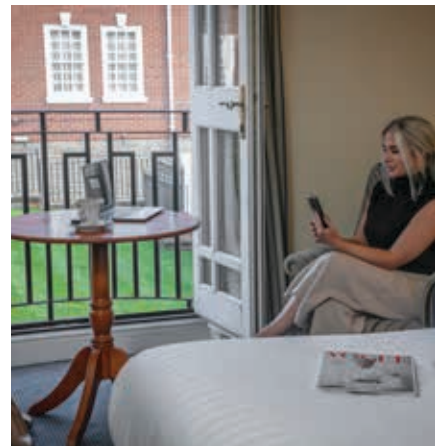


STAYING WITH US

BOOKING CONDITIONS

To confirm your booking

- You must sign the event confirmation within 7 days of your receipt, to confirm that you agree to the information detailed on it and to these terms and conditions. Failure to do so may result in space being released by us.
- You must accurately give us all the information we request at least 14 days prior to the start of your event.
- Where the booking includes accommodation, final numbers and a rooming list, together with the type of accommodation and length of stay will be required 14 days prior to the start of your event.

Cancellations or changes

- You may alter delegate numbers by up to 10% up to 14 days before the event. Changes of more than 10% will incur full cancellation charges. Delegate numbers charged will be those confirmed no later than 14 days before the event or the minimum number agreed at the time of booking, or the actual number of delegates which attended the event, whichever is the higher.
- If you have to cancel your event, you must let us know in writing as soon as you can. In the event that all or part of the affected space cannot be re-let and as long as we receive notice of your cancellation 6 months or more before your event, we will not charge any cancellation fee (unless you have paid a deposit, in which case we will retain your deposit). If we receive it thereafter, the following charges will apply:
 - Between 4 and 6 calendar months: 25% of the rate or rates quoted
 - Between 2 and 4 calendar months: 50% of the rate or rates quoted
 - 2 Months and under 100% of the rate or rates quoted

Payment terms

- Credit facilities must be pre-arranged, requested at the time of booking and are provided at our discretion.
- Credit accounts must be paid within 30 days of date of invoice or interest will be charged at 2% above base rate per month or part-month thereafter.
- Companies without account facilities will be required to pay a 25% deposit of the contracted total amount and final full pre-payment 14 days prior to the event.
- Any such payments required will be requested at the time of booking and will be non-refundable.
