Card settlement

- Use Sell value to settle the supplier and claim the difference (eg Expedia payments)
- Commission accounting if Customer card is used to pay the supplier. If deposit is paid using customer card option to settle it using customer card
- Automatic identification of Company card or Virtual card and post to finance
- Automatic reconciliation of Card statement using excel statement
