


## PROCESS FLOW - SAFETY BRIEFING ENROLMENT








The user can rewatch the video by clicking on it








The user will be directed to this page once he or she clicks "Acknowledge". Please ensure that the details for registering the completion of the training are entered correctly on the form before clicking "Submit".

The acknowledgement receipt should be kept by the contractor. The MICE LBS WSH team will perform an onsite spot check by scanning the QR code.

In the event that the MICE LBS WSH team is unable to verify that the contractor onsite has attended the briefing, the contractor will be asked to stop the work and complete the online safety briefing.

All contractors are strongly encouraged to attend and complete the safety briefing before starting work on site. The contractor will not be able to carry out their work onsite until they have completed the online safety briefing



### **NOTE THE FOLLOWING KEY POINTS:**

- All contractors are required to complete the safety briefing prior to the start of work
- The validity of the safety lasts for two years of the calendar year. After that, he/she should take it again.
- The contractors are required to reattend training if there are any amendments or update to the training deck as A result of legal updates or internal updates.
