

CLEAR EDGE GLASS Melbourne Build Expo Giveaway – Terms & Conditions

1. Introduction

- The “[Moët and Chandon Picnic Basket Giveaway]” (“Giveaway”) is organised by [CLEAR EDGE GLASS] (“Organiser”).
- By participating in the Giveaway, entrants (“Participants”) agree to be bound by these Terms and Conditions.

2. Eligibility

- The Giveaway is open to attendees of the Melbourne Build Expo 2025 (“Event”) on [22-23 October 2025].
- Participants must be aged 18 years or older at the time of entry.
- Employees, affiliates, agents, and immediate family members of the Organiser are not eligible to participate.

3. Entry Period

- The Giveaway begins on [22 October 2025 at 9.00am] and ends on [23 October 2025 at 6.00pm] (“Entry Period”).

4. How to Enter

- To enter, Participants must:
 1. Follow [**@clearedgeglass**] on Instagram during the Entry Period (one entry); and
 2. For one (1) additional entry, take a photo at the Organiser’s stand during the Event and post it on Instagram, tagging [**@clearedgeglass**].
- No purchase is necessary to enter or win.
- Each Participant may receive a maximum of two (2) entries.

5. Prizes

- One (1) major prize hamper valued at approximately [\$200].
- Two (2) smaller prize hampers valued at approximately [\$100]
- Prizes are non-transferable, non-exchangeable, and no cash alternative is offered.

- Winners must respond within 48 hours to claim their prize. If a winner does not respond within this period, the Organiser reserves the right to select an alternate winner.

- By entering, Participants agree that the Organiser may use their Instagram handle, name, and likeness for promotional purposes in connection with the Giveaway, without compensation, unless prohibited by law.
