



Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, February 27-March 4, 2022, naming Oliver Kinross Ltd. (PO Box 2952, New York, NY 10163) as the certificate holder. The following must be named as additional insured: Oliver Kinross Ltd. and their agents, trustees, officers, board members and employees and New York Convention Center Operating Corporation (Licensor), State of New York, the New York Convention Center Development Corporation, the New York State Urban Development Corporation d.b.a. Empire State Development, the Triborough Bridge and Tunnel Authority and their respective boards of directors, officers, agents and employees.

New York Build has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.
