#### **Demolition and Abatement:**



#### **Moynihan Train Station:**

R. Baker & Son performed the selective demolition on the project to transform New York City's historic Farley Post Office Building into the Moynihan Train Hall, an extension of the adjacent Pennsylvania Station, as part of a \$3 billion transportation complex redevelopment project.



#### Pier 42 Warehouse:

R. Baker & Son has completed demolition of the rusted metal warehouse aspart of Phase I of the project. Equipment utilized to take down the 80'W x 30'H x 240'L warehouse built in 1964 included a 130-ton crane with 170-foot boom, several excavators, and a lull.

#### 9/11 Memorial Museum:

R. Baker & Son was contracted to rig and set in place historicall artifacts into the museum, including Engine 21 and the iconic World Trade Center Cross. This cross-shaped section of steel beams was discovered in the rubble and erected at Ground Zero.



#### **Brooklyn Army Terminal:**

The Baker team was tasked the dismantling of ten freight elevator shafts approximately 125 ft. in height, as well as the removal of seven century-old 20,000 lb. capacity elevators, while preserving the integrity of the shafts.



#### **United Nations:**

The \$2.2 billion Capital Master Plan (CMP) project,removal of the iconic green glass curtain wall from all 39 stories of the Secretariat Building, and interior renovation throughout the facility including the General Assembly Hall. Also performing the rigging and relocation of artifacts and sculptures.



#### Fulton Fish Market :

The project called for emoval of the three-story, 50,000 sq. ft.structure which stood on the base of Pier 17 on South Street. Due to significant deterioration of the pier, all work was required to be performed utilizing primarily manual means and methods, with zero loading on the majority of the slab.
