Talent development is critical for the future of oil and gas decommissioning and abandonment (D&A), inclusive of both wells plug and abandonment (P&A) and facilities decommissioning, to ensure ongoing expertise and capability across the industry. 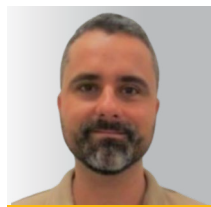

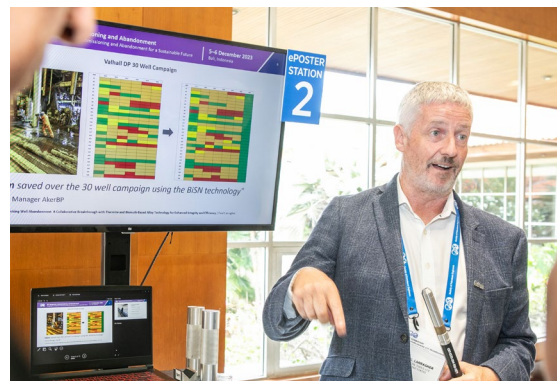
