Examples include, but are not limited to: (1) contributions to the knowledge and literature of offshore technology; (2) the design or invention of equipment, tools, or technical services; (3) humanitarian, safety or environmental efforts; (4) outstanding leadership; or (5) outstanding service to governments, companies, and organizations. Nominees for the OTC Distinguished Achievement Award should have achieved recognition in the regional offshore community. There are no limitations regarding nationality. The award may be given to an individual who is not a member of any of the sponsoring and endorsing organizations of OTC.
