COVID-19 SAFETY & HEALTH ACKNOWLEDGEMENT

Orlando Winterfest participants can expect enhanced health and safety measures throughout the venue and event. Guidelines set forth by the Centers for Disease Control and Prevention (CDC) and local authorities will be followed as it pertains to COVID-19. Participants must adhere to all posted protocol and instructions while in attendance at Orlando Winterfest.

While an inherent risk of exposure exists in any public space, the following practices and precautions can be expected.

- Face Coverings, required for all guests, vendors, and staff (ages 2 and up)
- Temperature Screening
- Enhanced Cleaning of All Public Space & High Traffic Areas
- Social Distancing
- Hand Sanitizer Stations
- Reduced Contact Points
- Directional, Safety, and Distancing Signage

By attending Orlando Winterfest, participants voluntarily assume all risks related to expose to exposure to COVID-19 for themselves and dependents, and acknowledge that health and safety requirements are understood and will be adhered to.

Guests and accompanying parties must not attend and will not be admitted if any of the following criteria apply:

- Contact with someone confirmed or suspected COVID-19 symptoms, recently testing positive and/or with pending COVID-19 test results
- Under 14-day self-quarantine orders
- Experiencing COVID-19 symptoms as identified by the CDC:
 - Fever or chills
 Loss of taste and/or smell
 - Cough
 Sore throat
 - Shortness of breath or difficulty breathing
- Congestion or runny noseNausea or vomiting

- Fatigue
- Muscle or body aches

• Diarrhea

• Headache

Updates to safety measures are subject to change at any time and will be updated based on current CDC and local guidelines.

ACCESSIBILITY
